Today i.e 19/04/2021 at about 3.00 pm received a reliable information that one non local suspected to be foreigner is residing at Lilong Bazar area by impersonating himself to be an Indian Citizen. Accordingly, a police team of Lilong Police Station led by me and assisted by SI N. Sudhir Singh rushed at Lilong Uku Mamang and conducted searched and verification of suspected non local from 3.20 pm to 4.30 pm. While conducting searched and verification of non-local, found one unknown non local person who is running scrap at Lilong Bazar near Jama Masjid in a very suspicious manner. Later he was detained for verification and identification. On verification, he could not furnish his real identity and becomes very suspicious. On further proper verification and identification, he identified himself as Mohammad Ramjan Ali aged about 34years S/o Md. Jalaluddin of Piyali Mari, P.O- Monakasha, PS-Shibganj, District- Chapainawabganj, Bangladesh and he also produced an invalid Passport VISA bearing No. AE4087924, date of expiry - 18/11/2017. Accordingly, the invalid Passport VISA bearing No. AE4087924 issued in the name of Mohammad Ramjan Ali S/o Md. Jalaluddin, M/o Most Aktara of Piyali Mari, Monakasha, Shibganj, Chapainawabganj, Bangladesh was seized by preparing a formal seizure memo on 19/04/2021 at 4.50 pm in presence of witnesses and Mohammad Ramjan Ali S/o Md. Jalaluddin of Piyali Mari, Bangladesh was also arrested by preparing a formal arrest memo on 19/04/2021 at 5.00 pm in presence of witnesses at the spot.

The arrested person and seized items are brought to police station for taking further necessary legal action.

Hence, a regular case under FIR No. 31(04)2021 LIL-PS U/s 14 A(b) Foreigner Act has been registered for investigation.
