

Today i.e 20/04/2021 at about 6.30 pm while I along with my police team of Lilong PS were performing law and order duty for imposing **NIGHT CURFEW** at Lilong Bazar area in c/w COVID-19 pandemic vide SP/TBL order no. 9/2(COVID-19)/2020/SP-TBL/2278 dated 18/04/2021 by using megaphone and dispersed the unlawful assembly. During my duty hour, our police team saw some unknown persons were confronting and forming an unlawful assembly at Lilong Bazar at 7.20 pm by violating the prohibitory order of night curfew. On seeing the situation, they were directed to disperse the unlawful assembly by giving warning. In that one individual aggressively warned the security personal with slang language and confronted with the security personnel on duty. In spite of dispersing the unlawful assembly subsequently one person later identified as Md. Rashid 52yrs S/o Late Md. Jahur Ali of Lilong Heinou Makhong along with his 03(three) associates namely 1) Mrs. Sajida Begum 40 years W/o Late Md. Khomei of Lilong Heinou Makhong, 2) Mrs. Ibem @ Jaheda 45 years W/o Md. Ibocha of Lilong Heinou Makhong, 3) Md. Imam 27 years S/o Md. Ibocha of Lilong Heinou Makhong and some unknown persons came towards the duty place i.e at Lilong Bazar at about 7.30 pm and obstructed the police personnel on duty by pushing, among them one Md. Sajida Begum 40 years also physically assault me by slapping while performing duty. They also violate the curfew imposed by Govt. of Manipur vide DC/TBL order no. 4/65/DC(TBL)/2009/L&O/Pt-VII/2998 Dated 17/04/2021. Accordingly, the above persons were arrested on 20/04/2021 at 8.00 pm except Mrs. Ibem @ Jaheda 45 years who managed to escape from the spot and brought to this PS for further necessary legal action.
