Sir,

I have the honour to report that today (03/05/2021) at about 6.00 am received a reliable information from my own source man that one vehicle lifter namely Singamayum Farid Khan (31) S/O Singamayum Abdul Salam of Lilong Atoukhong was loitering at his residence waiting for customer and concealing one stolen Honda Activa. Based on the specific information, a strong police team of Lilong PS led by OC Lilong PS including SI Md. Anwar Hussain, ASI Md. Giyasuddin and self along with volunteer member of ANJUMAN rushed to the spot under the supervision of Superintendent of Police, Thoubal. On reaching the spot, the police team cordoned the surrounding houses and conducted search operation. On searching, the police team found one suspected unknown person in a very suspicious manner near the pond. On seeing the police team, the unknown person fled away towards the paddy field but he was overpowered and apprehended near the paddy field. On spot verification, he identified himself as Singamayum Farid Khan (31) S/O Singamayum Abdul Salam of Lilong Atoukhong. Further, he stated that he along with Singamayum Imran Khan (26) S/O Singamayum Riaj Khan of Lilong Atoukhong had stolen one Honda Activa white in colour bearing registration No. Nil from in front of Lingel Office, Ghari Mamang Leikai near Mahindra Showroom on 30/04/2021 at about 2.45 pm and a sum of rupees 70, 000/(seventy thousand) which contained inside the above vehicle tool and the above vehicle were kept at his residence. Accordingly, the above Honda Activa bearing registration No. Nil and a sum Rs. 70,000/- (Seventy thousand) was recovered at his instance as pointed out by the accused Singamayum Farid Khan. On searching the accused Singamayum Imran Khan, he was not found at his residence evading from police arrest. So, the above vehicle Honda Activa white in colour bearing registration No. Nil, Chassis No. ME4JF914KLD114641, Engine No. JF91ED1114321 and a sum of Rs. 70, 000/-(Seventy thousand) was seized a preparing a formal seizure memo from the possession of Singamayum Farid Khan (31) S/O Singamayum Abdul Salam of Lilong Atoukhong on 03/05/2021 at 8.00 am and arrested the accused person Singamayum Farid Khan (31) S/O Singamayum Abdul Salam of Lilong Atoukhong by preparing a formal arrest memo on 03/05/2021 at 8.20 am the spot.

The arrested person along with seized items are brought to Police Station for further necessary action. It is therefore requested to kindly take necessary legal action against the arrested accused person as per provision of law.
