
Sir,

I have the honour to report that today i.e. 03/05/2021 at about 3.00 pm while I was in my office one of my source man appeared and informed me that one Phundreimayum Yasmin Begum (28) W/O Phundreimayum Mujibur of Lilong Haoreibi Turel Ahanbi near Kaleikhong is running drug vendor and selling illegal drugs to abusers at her residence (premises). Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to Officer in Charge, Lilong Police Station for kind information and further necessary action. So, I obtained the search authorization from Superintendent of Police, Thoubal. Then, a strong police team of Lilong Police Station led by OC/I.I.-PS including woman police along with members of ANJUMAN under the supervision of Superintendent of Police, Thoubal and source man with necessary equipment's rushed at the residence of Phundreimayum Yasmin Begum (28) W/O Phundreimayum Mujibur of Lilong Haoreibi Turel Ahanbi near Kaleikhong. On reaching the spot, the source man indicates the residence (drug vendor). Our police party cordoned the said residence and found one woman inside the house and she was detained for verification. I identified myself as police officer and my team also police personnel of Lilong PS team. Then, I asked the identity of the detainee in presence of the woman police and other witnesses. On that she identified her selves as Phundreimayum Yasmin Begum (28) W/O Phunderimayum Mujibur of Lilong Haoreibi Turel Ahanbi near Kaleikhong. Afterwards, I offered her whether she would want her body and belongings to be searched in the presence of civil witnesses or Gazetted officer or Executive Magistrate. In that, she offered to search her body and belonging in presence of a Gazetted officer as witnesses. Accordingly, I informed Shri H. Johny Sharma, MPS, SDPO-TBI. to be witness during searching the body and belonging of the above individuals. On searching the body in presence of Shri H. Johny Sharma, MPS, SDPO-TBI. as Gazetted Police Officer witness including woman police, no incriminating articles were found. On searching the belonging in presence witnesses, the police team found one cartoon box containing 67/(sixty seven)nos of bottles of 100 ml capacity of suspected Chlorpheniramine Maleate & Codeine Phosphate Syrup near her bed. On further searching the wooden almirah, found three capsule box marked as SPAS-ROXY PLUS (SP Capsule) and one small white plastic bottle containing 579/(five hundred and seventy nine) nos. of suspected S.P. Capsule. On further searching, the police team detected one white plastic bottle container containing of suspected Heroin weighing 262.8 grams including the weight of container of small plastic polythene container.

Finally all the exhibits were seized by preparing a formal weighing and seizure memo on 03/05/2021 at 5.30 pm from the possession of Phunderimayum Yasmin Begum (28) W/O Phundreimayum Mujibur of Lilong Haoreibi Turel Ahanbi near Kaleikhong and arrested the accused person Phundreimayum Yasmin Begum (28) W/O Phundreimayum Mujibur of Lilong Haoreibi Turel Ahanbi near Kaleikhong by preparing formal a arrest memo on 03/05/2021 at 5.50 pm respectively.

The arrested person along with seized items are handed over to you for taking further necessary legal action against her.
