

That on (04/05/2021) at about 11.30 pm combined team of Lilong Police Station led by OC Lilong PS and assisted by S.I. N. Sudhir Singh and Havildar Md. Kamal Hassan of CDO/TBL conducted frisking and checking in front of Lilong Police Station gate in order to detect movement of antisocial elements and transportation of illegal items and imposing night curfew in c/w pandemic covid-19. While conducting frisking and checking two unknown person were proceeding from Imphal towards Thoubal by riding one Honda Dio identified bearing No. MN01AE- 8517 in a suspicious manner. Due to suspicious manner, they were signal to stop. Instead of stopping, they proceeded towards Thoubal side in a high speed but they were overpowered at the spot. On spot verification, they identified himself as Md. Subhan Khan (20) S/O Md. Abdul Wahid of Lilong Chaobok Mairenkul ITI Road and Md. Rohid Ahamed (22) S/O Md. Ayub Khan of Lilong Leihaokhong. On further proper verification, they disclosed that on 03/04/2021 at about 2.00 pm they had stolen one Honda Dio bearing registration No. MN01AE-8517 from the Singjamei Chingamathak. So, the above vehicle Honda Dio grey in colour bearing registration No. MN01AE-8517, Engine No. JF39ET5017695, Chassis No. ME4JF39L.GJT005349 was seized by preparing a formal seizure memo from the possession of Md. Subhan Khan (20) S/O Md. Abdul Wahid of Lilong Chaobok Mairenkul ITI Road on 05/05/2021 at 1.00 am and arrested the accused person Md. Subhan Khan (20) S/O Md. Abdul Wahid of Lilong Chaobok Mairenkul ITI Road and Md. Rohid Ahamed (22) S/O Md. Ayub Khan of Lilong Leihaokhong by preparing a formal arrest memo on 05/05/2021 at 1.20 am and 1.30 am respectively.

The arrested persons along with seized items are brought to Police Station for further necessary action. It is therefore requested to kindly take necessary legal action against the arrested accused persons as per provision of law.
