

Sir,

I have the honour to report that today i.e. 08/05/2021 at about 5.00 am while I was in my office one of my source man appeared and informed me that that (1) Md. Nawaz Khan @ Aphol (35) S/O (L) Md. Yaima of Lilong Haoreibi Turel Ahanbi Ubakthong Makha (2) Md. Riyaz Khan (31) S/O (L) Md. Yaima of Lilong Haoreibi Turel Ahanbi Ubakthong Makha are running drug vendor and selling illegal drugs to abusers at their residence (premises). Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to Officer in Charge, Lilong Police Station for kind information and further necessary action. So, I obtained the search authorization from Superintendent of Police, Thoubal. Then, a strong police team of Lilong Police Station led by OC/LIL-PS including woman police assisted by SI N. Sudhir Singh, ASI Md. Serakhan and me under the supervision of under the supervision of Superintendent of Police, Thoubal and source man with necessary equipments rushed at the residences of (1) Md. Nawaz Khan @ Aphol (35) S/O (L) Md. Yaima of Lilong Haoreibi Turel Ahanbi Ubakthong Makha (2) Md. Riyaz Khan (31) S/O (L) Md. Yaima of Lilong Haoreibi Turel Ahanbi Ubakthong Makha. On reaching the spot, the source man indicates the residence (drug vendor). Our police party cordoned the said residence and found two persons inside the house and they are detained for verification. I identified myself as police officer and my team also police personnel of Lilong PS team. Then, I asked the identity of the detainee in presence of the woman police and other witnesses. On that they identified themselves as (1) Md. Nawaz Khan @ Aphol (35) S/O (L) Md. Yaima of Lilong Haoreibi Turel Ahanbi Ubakthong Makha (2) Md. Riyaz Khan (31) S/O (L) Md. Yaima of Lilong Haoreibi Turel Ahanbi Ubakthong Makha. Afterwards, I offered them whether they would want their body and belongings to be searched in the presence of civil witnesses or Gazetted officer or Executive Magistrate. In that, they offered to search their body and belonging in presence of a Gazetted officer as witnesses. Accordingly, I informed Shri H. Johny Sharma, MPS, SDPO-TBL to be witness during searching the body and belonging of the above individuals. On searching the body in presence of Shri H. Johny Sharma, MPS, SDPO-TBL as Gazetted Police Officer witness including woman police, two mobile phone handset (1) Samsung Duos along with sim card bearing mobile phone no. 8118904282 (2) Samsung Galaxy A21s along with sim card bearing mobile phone no. 6909159107 were found from the possession of accused Md. Nawaz Khan @ Aphol and no incriminating articles were found from the possession of accused Md. Riyaz Khan. On searching the belonging in presence witnesses, the police team found 6(six) blue plastic packet containing the following suspected WY tablets (Methamphetamine) (1) 199/ nos. weighing 20.8 grams (2) 200/nos. weighing 20.9 grams (3) 200/nos. weighing 19.4 grams (4) 195 nos. weighing 19.2 grams (5) 200/nos. weighing 19.8 grams (6) 200 nos. weighing 20.1 grams including the weight of container respectively under the bed of accused Md. Nawaz Khan @ Aphol and the exhibits have been marked as 1, 2, 3, 4,5 and 6 identification. On further searching, found 3/(three) nos. of bottles of 100 ml capacity of suspected Chlorpheniramine Maleate & Codeine Phosphate Syrup marked as P-KUFF and one plastic bottle marked as LEISHNA containing of suspected Heroin weighing 2.3 gram excluding the weight of container and 18/(Eighteen) nos. of empty plastic bottle container and 5/(five) nos. of lighter which are used drugs business under the bed of accused Md. Riyaz Khan.

Finally the exhibits containing of suspected WY tablets and two mobile phone handset were seized by preparing a formal weighing and seizure memo on 08/05/2021 at 7.30 am from the possession of Md. Nawaz Khan @ Aphol (35) S/O (L) Md. Yaima of Lilong Haoreibi Turel Ahanbi Ubakthong Makha and the exhibits containing of Heroin and codeine phosphate and empty bottle and container were seized by preparing a formal weighing and seizure memo on 08/05/2021 at 7.50 am and arrested the accused persons (1) Md. Nawaz Khan @ Aphol (35) S/O (L) Md. Yaima of Lilong Haoreibi Turel Ahanbi Ubakthong Makha (2) Md. Riyaz Khan (31) S/O (L) Md. Yaima of Lilong Haoreibi Turel Ahanbi Ubakthong Makha by preparing formal a arrest memo on 08/05/2021 at 8.00 am and 8.10 am respectively.

The two arrested person along with seized items are handed over to you for taking further necessary legal action against them.
