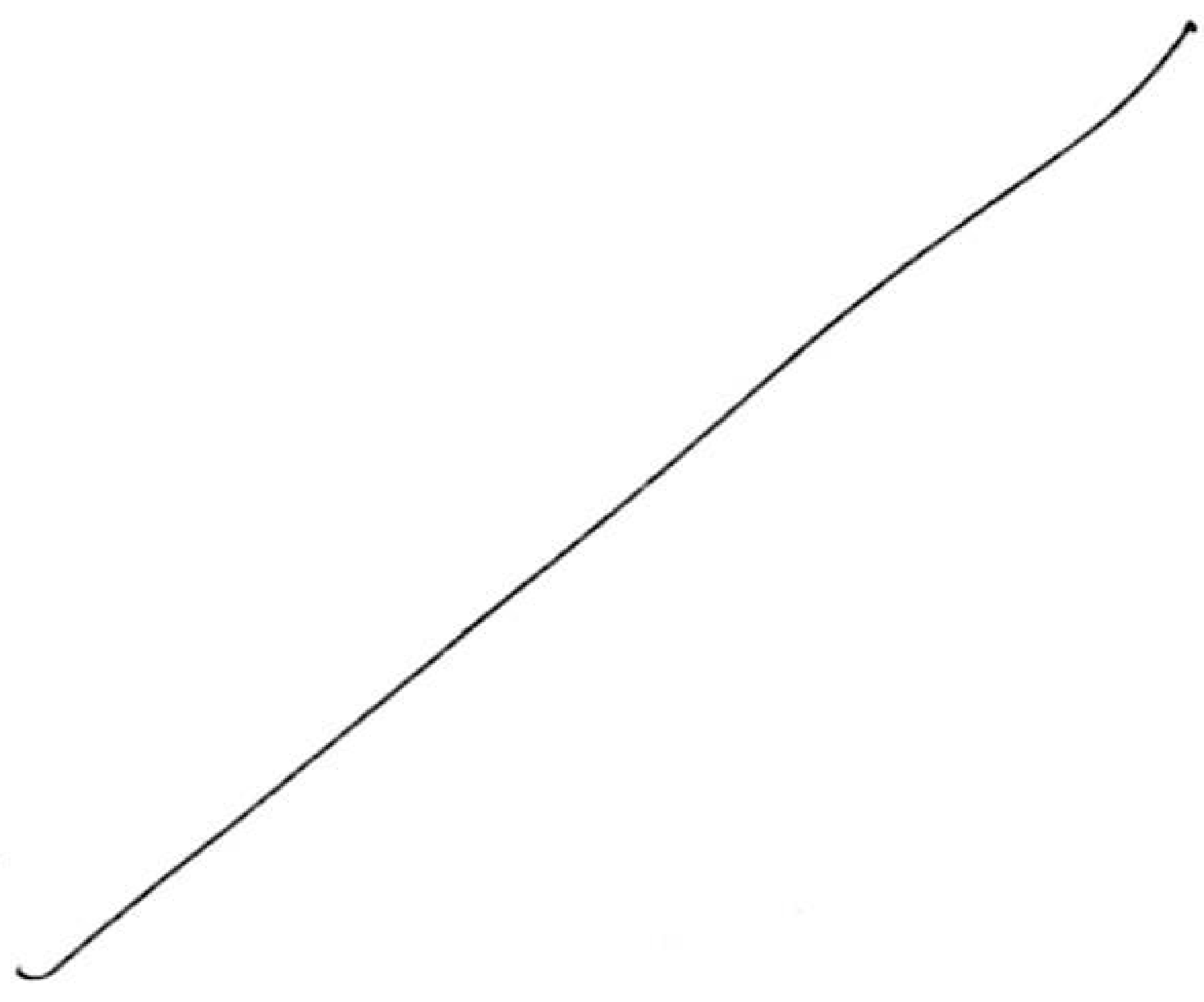
Sir,
