I have the honour to report that on 25/05/2021 at about 7.05 pm while I was coming on my vehicle Alto car bearing registration no. Amuba of Lilong Haoreibi Tuzel Ahambi Ubakthong stopped my vehicle at Lilong Haoreibi Makha Leikai Asem Leirak Makok and snatch my vehicle key. Then, I was pull out from my car and started assaulted me by using dao, stick etc. and Kidnapped me from the spot. As a result, I received injuries on my persons.
