Sir,

I have the honour to report that today i.e 26-05-2021 at around 10:30 am received a reliable information that some unknown shops owner of Lilong Ushoipokpi area selling combustible material and used to store huge quantity of combustible material like petrol and diesel rashly or negligently so as to endanger human life and surrounding people at his residence for their wrongful gain. On received of above information, a strong police team of Lilong PS including women police under the supervision of OC LIL-PS rushed at Lilong Ushoipokpi Bazar and conducted searched drive at the said area. During searched operation, found one person namely Md. Nasir aged about 30 yrs S/o Md. Ibocha of lilong Ushoipokpi was selling combustible material along the NH 102 at Lilong Ushoipokpi Bazar like Diesel without permission from the concern authority for his wrongful gain so rashly or negligently so as to endanger human life and stored combustible material i.e 3 (three) litres of Diesel. So the above combustible material Diesel was seized by preparing a formal seizure memo on 26/05/2021 at 11.20 and arrested the above person Md. Nasir aged about 30 yrs S/o Md. Ibocha of lilong Ushoipokpi by preparing a formal arrest memo on 26/05/2021 at 11.25 am

The arrested person along with the seized items are brought to police station for taking necessary legal action against him.
