

Subject:- Report.

Sir,

I have the honour to report that today i.e., 26/05/2021 at around 11:30 am received a reliable information that some person of Lilong Kaleikhong Makok along the NH-102 selling combustible material and used to store huge quantity of combustible material like petrol and diesel rashly or negligently so as to endanger human life and surrounding people at his residence for their wrongful gain. On received of above information, a strong police team of Lilong PS including women police under the supervision of OC/LIL-PS rushed at Lilong Kaleikhong Makok along the NH-102 and conducted searched drive at the said area. During searched operation, found one person namely Md. Sahidur (25) yrs. S/o (L) Md. Alimuddin of Lilong Mairenkhun was selling combustible material at Lilong Kaleikhong Makok along the NH-102 like Petrol without permission from the concern authority for his wrongful gain so rashly or negligently so as to endanger human life and stored combustible material i.e., 3 (three) liters of Petrol. So the above combustible material Diesel was seized by preparing a formal seizure memo on 26/05/2021 at 12:10 pm and arrested the above person Md. Sahidur (25) yrs. S/o (L) Md. Alimuddin of Lilong Mairenkhun by preparing a formal arrest memo on 26/05/2021 at 12:15 pm.

The arrested person along with the seized items are brought to police station for taking necessary legal action against him.
