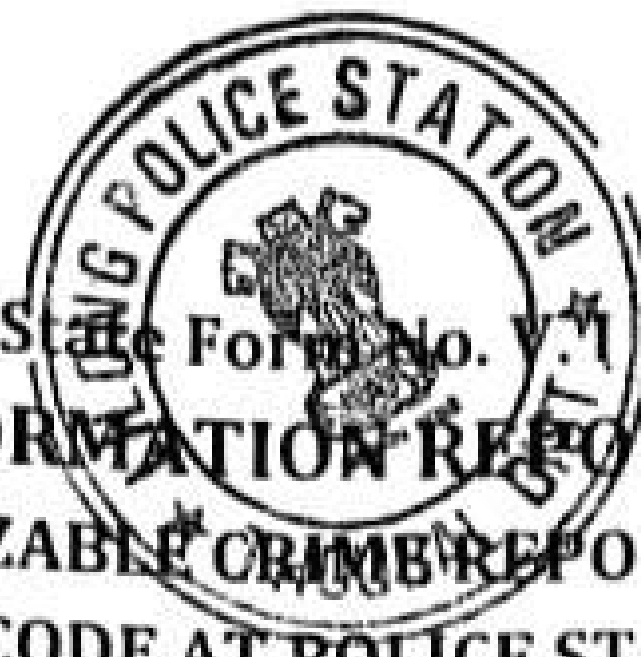


Sir,


I have the honour to report that today i.e., 01/06/2021 at about 10:00 am received a reliable information that some stolen Honda Activa are concealing at the residence of Phusam Mustak (24) S/O P. Tayeb Ali of Lilong Chingkhamb Makha. On received of above information, organized combined team of CDO/TBL, Havildar Md. Kamal Hassan Golf 80, H.C W. Premananda Singh Golf 43, Havildar A. Rameshwar Singh Golf 26, Lilong Police team and myself led by Inspt N. Tikendra Meetei, OC CDO/TBL and rushed to the said residence under the supervision of Addl. SP/TBL (Ops) and under the overall supervision of Superintendent of Police, Thoubal. On reaching the spot, found two unknown person in a very suspicious manner and they were detained for verification. On spot verification, they identified themselves as Phusam Mustak (24) S/O P. Tayeb Ali of Lilong Chingkhamb Makha and Phusam Altaf (22) S/O P. Tayeb Ali of Chingkhamb Makha. On further searching the residence, found one suspected Honda Activa red in colour bearing No. Nil parking at the shed. On asking about the said Honda Activa red in colour, they disclosed that they had purchased one stolen Honda Activa bearing No. MN01AF-8153, Chassis No. ME4JF50ABKT784681, Engine No. JF50ET7780751 from one Md. Imtias Shah (21) S/O (I.) Md. Ajit Shah of Lilong Chingkhamb Dam Makha which tampered Chassis No and Engine No. at the rate of Rs. 26,000/(twenty six thousand) knowingly that the vehicle is stolen one since 10 days back. The chassis No. and Engine No. were tempered by one Md. Abdul Nashir (41) S/O Md. Abdul Hakim of Lilong Chaobok Mairenkun and the fake R.C. book of the above vehicle was prepared by him. So the above vehicle along with R.C. book was seized by a preparing a formal seizure memo on 01/06/2021 at 2.00 pm from the possession of Phusam Mustak (24) S/O P. Tayeb Ali of Lilong Chingkhamb Makha and arrested the above two persons namely Phusam Mustak (24) S/O P. Tayeb Ali of Lilong Chingkhamb Makha and Phusam Altaf (22) S/O P. Tayeb Ali of Chingkhamb Makha on 01/06/2021 at 2:10 pm and 2:20 pm respectively by preparing a formal arrest memo.

On follow up action, the combined CDO/TBL team rushed at the residence of Md. Imtias Shah (21) S/O (I.) Md. Ajit Shah of Lilong Chingkhamb Dam Makha but he was not found at his residence absconding from police arrest. On further follow up action, the combined CDO/TBL rushed at the residence of Md. Abdul Nashir (41) S/O Md. Abdul Hakim of Lilong Chaobok Mairenkun but he was not found at his residence absconding from police arrest. On further searching the residence, found the following three suspected stolen two wheeler vehicles (1) Honda Dio yellow in colour bearing No. Nil, Chassis No. ME4JF39HKJU013881, Engine No. JF39EU4059403 (2) Honda Activa brown in colour bearing No. Nil, Chassis No. ME4JF916AMG022376, Engine No. JF91EG302250 (3) Honda Activa blue in colour bearing No. Nil, Chassis No. ME4JF50AHHKG221059, Engine No. JF50EG0220702. Latter, the above three vehicles are seized by preparing a formal seizure memo on 01/06/2021 at 3:00 pm, 3:10 pm and 3:20 pm respectively.

The two arrested persons along with seized items are handed over to you for further necessary action against them.
