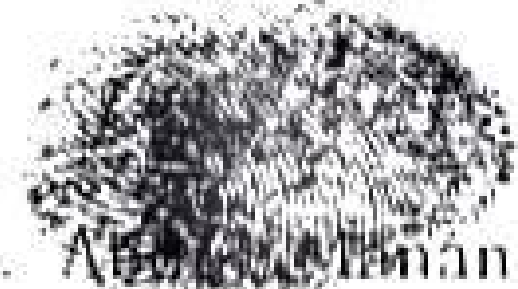
Subject:- Report.

I the undersigned would like to state that today i.e 11-06-2021 at around 08:30 pm, my son namely Md. Abdul Wahid aged about 26 yrs S/o Md. Abdul Kalam of Lilong Usoipokpi Tharaorok was assaulted by 1) Abdul Nasir, 28 yrs S/o Late Ibo of Lilong Meirenkhun Tathabi, 2) Md. Akbar Ali @ Aboicha, 21 yrs S/o Hakim of of Lilong Meirenkhun Tathabi near the residence of Md. Sanayai of Lilong Usoipokpi Tharaorok by using an iron rode. As a result of which my son received bleeding injury on his head and was evacuated to hospital for medical treatment. They have also badly damaged one four wheeler Maruti Alto LXI, gold in colour b/r no WB-66 G 9214.

I therefore request your goodself to kindly initiate necessary legal actions against the above noted persons for the end of justice.
