Subject:- Report.

Respected Sir,

I have the honour to report that today i.e. 07/07/2021, at about 6:20 pm while I was discharging duty at Lilong Bazar along with my team received a telephonic information from an unknown individual that family members two houses were quarrelling and physical fighting by holding deadly weapons like barrel guns and knives. Without any delay I informed the matter to OC Lilong PS as OC Lilong PS and his team also discharging duty at Lilong Bazar. In that OC Lilong PS instructed me to proceed at the spot with my team to pacify the matter. OC Lilong PS also further told me that he along with his police team will also proceed at the spot immediately. I also informed the matter to our police control room through mobile phone and I along with my team proceed towards the spot. When I along with my team reached at the spot some individuals including male and female were found gathering with a view to organize a mob and asked them to left the location immediately as curfew is already been imposing everywhere due to pandemic disease of COVID-19. In the meanwhile some localities told me that the fighting was occurred between the family members of Mayangmayum Jalaluddin @ Ithoi 45yrs and Mk. Nurjaman 65yrs. The localities further informed that they had seen three barrel guns were holding by Makakmayum Ahmed Ali @ Abothem and his associates. I along with my team went to the house of Mayangmayum Jalaluddin @ Ithoi 45yrs and warned the individuals who were found gathering there to leave the place immediately except the family members of both families as our senior officers are also coming at the spot.

In the meanwhile I heard a shouting/screaming sound were our police vehicle (gypsy) which is parked on the road with the pilot (gypsy driver). So, I along with my team rushed towards the vehicle and it came to know that our gypsy driver (i.e pilot) namely Md. Nazir Ahmed, Rfn. No. 062010774 of 6 MR presently attached with CDO Thoubal Unit who is sitting on the driver seat of our gypsy was severely beaten up by some unknown culprits but unable to find out them due to the darkness. OC Lilong PS along with his team also arrived at the spot and controlled the situation.

Later on, our gypsy driver namely Md. Nazir Ahmed told me that while he was sitting inside the gypsy by discharging duty due to the other police team were at the spot to pacify the situation and by taking the advantage of loneliness he was dragged out from the vehicle and severely beaten him by some individuals namely 1) Makakmayum Ahmed Ali @ Abothem, 2) Makakmayum Sameer S/O Mk. Ahmed, 3) Mk. Boicht @ Rothe s/o. Mk. Anuwar, 4) Mk. Sakir s/o. Mk. Anuwar, 5) Mk. Ajeer Ali s/o. Mk. Anuwar and 6) Mk. Sahir s/o. Mk. Anuwar, 7) Mk. Sajid S/O Mk. Ahmed, 8) Mk. Sakil s/o. Mk. Ahmed by using hard object/ deadly weapons with an intent to obstruct him from discharging his lawful duty. They all are the resident of Lilong Ushoipokpi Suptu Karong. Our gypsy driver Md. Nazir Ahmed further told me that accused no. 2 Makakmayum Sameer S/O Mk. Ahmed, no. 7 Mk. Sajid S/O Mk. Ahmed and accused no. 1 namely Mk. Ahmed Ali @ Abothem (Who is said to be serving as Head Constable in Manipur Police department and presently posted at District police Tengnoupal) tried to snatch his service weapon forcibly. So, the act of the accused Mk. Ahmed Ali @ Abothem who also serving as a Head Constable in Manipur Police department who also having the knowledged of all the rules and regulations of the police department is a grave misconduct and causes bad reputation of police department. Due to receiving serious injury of Md. Nazir Ahmed, Rfn. No. 062010774 of 6 MR presently attached with CDO Thoubal Unit was evacuated to Noor Hospital Lilong for medical treatment.

I request you to kindly take up further necessary legal actions to all the above mention accuses without any delay as they were obstructing our duty to maintain law and order situation.
