Subject:- Report

Sir,

I have the honour to report that today i.e. 02/08/2021 at about 3.00 am one of my source man gave an information that one Makakmayum Abdul Wahid (25) S/O Makakmayum Abdul Manal of Lilong Ushoipokpi Tharaorok and one Mrs. Nashima (23) W/O Makakmayum Abdul Wahid of Lilong Ushoipokpi Tharaorok were running drug vendor and selling illegal drugs to drugs abusers at their residence (premises). Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to Superintendent of Police, Thoubal for kind information and further necessary action. Accordingly, I obtained the search authorization warrant from Superintendent of Police, Thoubal. Immediately, organized a combined team of CDO/TBL led by me, Lilong Police Station team including lady police, a team of 16 AR under the supervision of Additional Superintendent of Police, Thoubal (Ops) under the overall supervision of Superintendent of Police, Thoubal along with source man with necessary equipments rushed at the residence of Makakmayum Abdul Wahid (25) S/O Makakmayum Abdul Manal of Lilong Ushoipokpi Tharaorok and Mrs. Nashima (23) W/O Makakmayum Abdul Wahid of Lilong Ushoipokpi Tharaorok. On reaching the spot, the source man indicates the residence (drug vendor). So, the combined team, cordoned the said residence and detained two persons who were inside the house for verification. I identified myself as police officer and my team also police personnel of CDO/TBL and Lilong PS team and 16 AR. Then, I asked the identity of the detainee in presence of the woman police and other witnesses. On that they identified themselves as Makakmayum Abdul Wahid (25) S/O Makakmayum Abdul Manal of Lilong Ushoipokpi Tharaorok and one Mrs. Nashima (23) W/O Makakmayum Abdul Wahid of Lilong Ushoipokpi Tharaorok. Afterwards, I offered them whether they would want their body to be searched in the presence of Gazetted officer or Executive Magistrate. In that, they offered to search their body in presence of a Gazetted officer as witnesses. Accordingly, I informed Shri Sachidananda Soibam, MPS, Addl SP(Ops)/TBL to be witness during searching the body of the above individuals. On searching the body in presence of Shri Sachidananda Soibam, MPS, Addl SP(Ops)/TBL as Gazetted Police Officer witness including woman police, the police team found one Samsung Key pad mobile phone handset along with sim cards from the possession of accused Makakmayum Abdul Wahid and no incriminating articles was found from accused Mrs. Nashima . On searching the belonging, the police team detected eight soap cap inside black polythene containing of suspected Heroin weighing (1) 72.1 gram (2) 71.6 gram (3) 11.3 grams (4) 12.8

gram (5) 12.8 gram (6) 11.4 gram (7) 13.0 gram (8) 12.5 grams respectively including the weight of plastic container, totaling 217.5 grams and seven empty soap cap from the bed of accused Makakmayum Abdul Wahid (25) S/O Makakmayum Abdul Manal of Lilong Ushoipokpi Tharaorok. On further searching, the police team detected one small polythene containing of suspected Heroin weighing 42.8 gram including the weight of plastic container and 28/(twenty eight) nos of empty small plastic bottle container from inside the red colour lady hand bag which belongs to accused Mrs. Nashima (23) W/O Makakmayum Abdul Wahid of Lilong Ushoipokpi Tharaorok. On further searching, found one small box made of Galvanized Coated Sheet(Paksi) containing a sum of Rs. 1,82,000/ (one lakh eighty two thousand) which is the sale proceed money of illegal drugs from inside the godrej. Further, the police team found one Maruti Alto car bearing registration No. WB66G-9214 which is used in transportation of illegal drugs items by accused Makakmayum Abdul Wahid.

Finally all the exhibits were seized by preparing a formal weighing and seizure memo at 5.30 am and 5.40 am from the possession of Makakmayum Abdul Wahid (25) S/O Makakmayum Abdul Manal of Lilong Ushoipokpi Tharaorok and one Mrs. Nashima (23) W/O Makakmayum Abdul Wahid of Lilong Ushoipokpi Tharaorok and arrested the accused person Makakmayum Abdul Wahid (25) S/O Makakmayum Abdul Manal of Lilong Ushoipokpi Tharaorok and one Mrs. Nashima (23) W/O Makakmayum Abdul Wahid of Lilong Ushoipokpi Tharaorok by preparing a formal arrest memo at 6.00 am and 6.10 am respectively.

The arrested person along with seized items are handed over to you for taking further necessary legal action against them.
