Sir,

I have the honour to report that on 29.07.2021 at @ 10 am the following persons namely 1) Md. Abdul Hakim aged about 30 yrs s/o Late Mr. Amuba (Ex Medhan) of Lilong Tumbi Dam Makha and 2) Md. Ali aged about 65 yrs s/o (1) Mr. Amubi of Lilong Dam Makha have took a sum of Rs, 22000/- (Two lacs & twenty thousand) only from me by believing me to give beetel nut (Supari) at the residence of said Md. Abdul Hakim. However, the said persons didn't give me the beetel nut, instead they threatened me using hard & abusive language. In the meantime, the said Md. Abdul Hakim refunded a sum of Rs, 1,27,500/- (one lac twenty seven thousand & five hundred) only on 31.07.2021 through one Mr. Rajoodien (37) s/o Mr. Dho of Lilong Tolenkhem. The remaining amount didn't refund till date and still they are cheating to me.

It is therefore requested for taken up necessary legal action against them.
