Subject :- Report.

Sir,

I have the honour to report that today i.e. 12/08/2021 at about 3.00pm while I was in my office one of my source man appeared at my office and informed me that one unknown woman of tribal will be transporting illegal drugs of Heroin and supplied to Lilong Sangomsang area. After verifying the veracity of the source report, the information was taken down in writing and a copy of the same was forwarded to Officer in Charge, Commando Unit, Thoubal. Accordingly, I obtaining searched authorization from Superintendent of Police, Thoubal. Accordingly, I along with my team and a team of Lilong PS including lady police of Lilong PS and team of Youth Athletic Development Association (YADA) including source man under the supervision of Shri. Sachidananda Soibam, MPS Addl. Superintendent of Police,(Ops)/Thoubal and under the overall supervision of Shri. Jogeschandra Haobijam, IPS, Superintendent of Police, Thoubal District, Manipur conducted random frisking and checking at Lilong Sangomsang near Stone Crusher along NH/102. During the frisking and checking at 4:00 p.m. one unknown women tribal was seen coming on foot from Waithou side towards Lilong side carrying one bag red and black in colour in a very suspicious manner. Due to the suspicious she was signal to stop for verification. On seeing the police team, she fled away towards the paddy filed but she was overpowered and detained at the spot for verification.

On preliminary verification, she identified herself as Mrs. Cho-Chong 29yrs W/O Lal-Neong of Sokom Village A/P L. Bungjoi Village, District-Chandel. Then, she was offered to search her body in presence of Gazetted police officer or Magistrate. In that she opted to search her body in presence of Gazetted police officer. Accordingly, I informed Shri Sachidananda Soibam, MPS Addl SP(Ops)/TBL to be witness on searching the body of Mrs. Cho-Chong 29yrs W/O Lal-Neong of Sokom Village A/P L. Bungjoi Village, District-Chandel. On searching the body in presence of Shri Sachidananda Soibam, MPS, Addl SP(Ops)/TBL as Gazetted Police Officer witness including woman police, the police team found one MI Note 4 Pro mobile phone handset with one Airtel SIM card bearing mobile no. 6909201216 from the possession of accused person namely Mrs. Cho-Chong 29yrs W/O Lal-Neong of Sokom Village A/P L. Bungjoi Village, District-Chandel. Further, on searching of her belonging of carrying one bag red and black in colour, the police team detected one black polythene containing of suspected Heroin powder weighing (1)11.8 grams (2)11.2 grams (3)13 grams (4)11.3 grams (5)11.4 grams (6)19.8 grams (7)22.1 grams respectively including the weight of plastic container when weight by using weighing balance, totalling `100.6 grams.

Finally all the exhibits i.e. suspected Heroin powder including mobile phone, carrying bag red and black in colour and one black polythene were seized by preparing a formal weighing and seizure memo on 12/08/2021 at 5:30 p.m. from the possession of Mrs. Cho-Chong 29yrs W/O Lal-Neong of Sokom Village A/P L. Bungjoi Village, District-Chandel and arrested the accused person namely Mrs. Cho-Chong 29yrs W/O Lal-Neong of Sokom Village A/P L. Bungjoi Village, District-Chandel by preparing a formal arrest memo on 12/08/2021 at 5:45 p.m. from the spot i.e. Lilong Sangomsang near Stone Crusher along NH/102.

The arrested accused person along with the seized articles are handed over to you for taking further necessary legal action against her.
