Subject: Registration of complaint regarding fire incident that occurred in the early hours of 01.08.2021 at the Office of Sub-Divisional Officer, Lilong.

Sir,

In inviting a reference to the above subject, I am to state that a fire incident destroying the Office properties of the undersigned, Office of Sub-Deputy Collector, Lilong, Office of Block Development Officer, Lilong C.D. Block and Assistant Registrar Cooperative Society, Lilong occurred in the early hours of today, the 1st September, 2021, at around 12:03 am. The primary cause of fire is yet to be established. However, in view of fire pattern, it is suspected that some external interventions might have been made to ignite the fire. Total Approximate value of the estimated damage is Rs. 68, 38,500/- (Rupees Sixty eight lakh thirty eight thousand five hundred) only.

It is therefore requested to enquire into the incident and find out the culprits if any, and take up appropriate legal action at the earliest.
