Subject :- Report.

Sir,

I have the honour to report that today i.e. 04/09/2021 at about 03:30 pm while I was in my office one of my source man appeared at my office and informed me that two unknown tribal including a woman of tribal will be transporting illegal drugs of Heroin for supplying to their drug business partner at Lilong Haoreibi Turel Ahanbi Ubakthong Makha Idigah Road area. After verifying the veracity of the source report, the information was taken down in writing and a copy of the same was forwarded to Officer in Charge, Commando Unit, Thoubal. Accordingly, I obtained searched authorization from Superintendent of Police, Thoubal. Then, I along with my team and a team of Lilong PS including lady police along with the source man with necessary equipment under the supervision of Shri. Sachidananda Soibam, MPS Addl. SP(Ops)/Thoubal and under the overall supervision of Shri. Jogeschandra Haobijam, IPS, Superintendent of Police, Thoubal District, Manipur conducted random frisking and checking at Lilong Haoreibi Turel Ahanbi Ubakthong Makha near Idigah along Idigah Road. During the frisking and checking at 04:00 p.m. one unknown person was seen coming on foot from Atoukhong side towards frisking point with carrying one Polythene bag black in colour in a very suspicious manner. Due to the suspicious he was asked to stop for verification. On seeing the police team, he tried to fled away towards Idigah ground but he was overpowered and detained at the spot for verification.

On preliminary verification, he identified himself as Md. Mujibur 43 yrs S/O Md. Amjad Ali @ Tomba of Lilong Atoukhong Maning Leikai, Thoubal District, Manipur. Then, he was offered to search his body in presence of Gazetted police officer or Magistrate. In that he opted to search his body in presence of Gazetted police officer. Accordingly, I informed Shri Sachidananda Soibam, MPS Addl SP(Ops)/TBL to be witness during searching the body of Md. Mujibur 43 yrs S/O Md. Amjad Ali @ Tomba of Lilong Atoukhong Maning Leikai, Thoubal District, Manipur. On searching his body in presence of Shri Sachidananda Soibam, MPS, Addl. SP(Ops)/TBL as Gazetted Police Officer witness, the police team found one MI Redmi Note 8 mobile phone handset with two SIM card i.e., one JIO SIM card bearing mobile no. 7005172212 and one VODAFONE SIM card bearing mobile no. 8258858471 from the possession of accused person namely Md. Mujibur 43 yrs S/O Md. Amjad Ali @ Tomba of Lilong Atoukhong Maning Leikai, Thoubal District, Manipur. Further, on searching of his belonging the police team detected one black colour polythene containing 22 (twenty two) nos. of soap case (13 nos. in dark red colour, 1 no. in light red in colour, 4 nos. in dark blue in colour, 3 nos. in light blue colour and 1 no. in green colour) which were containing suspected Heroin powder packed in transparent polythene. So, all the transparent polythene packets were marked as P1 to P22 weighing of (1) 12.5 grams in P1, (2) 12.6 grams in P2, (3) 12.6 grams in P3, (4) 13.4 grams in P4, (5) 11.7 grams in P5, (6) 12.7 grams in P6, (7) 14.9 grams in P7, (8) 10.4 grams in P8, (9) 12.0 grams in P9, (10) 12.0 grams in P10, (11) 13.6 grams in P11, (12) 12.8 grams in P12, (13) 12.7 grams in P13, (14) 12.4 grams in P14, (15) 13.3 grams in P15, (16) 13.8 grams in P16, (17) 10.5 grams in P17, (18) 9.0 grams in P18, (19) 11.8 grams in P19, (20) 12.2 grams in P20, (21) 9.9 grams in P21 and (22) 12.7 grams in P22 respectively including the weight of plastic polythene when weighted by using weighing balance, totalling `269.5 grams. Then, he also disclosed that the said seized drugs were delivered to him by two unknown individuals of Moreh (one male and one woman) who came on a Bolero white in colour. Therefore, the said drugs i.e., Heroin powder and one MI Redmi Note 8 mobile phone handset with two SIM card i.e., one JIO SIM card bearing mobile no. 7005172212 and one VODAFONE SIM card bearing mobile no. 8258858471 were seized by preparing a formal weighing and seizure memo on 04/09/2021 at 04:40 p.m. from the unauthorised possession of **Md. Mujibur 43 yrs. S/O Md. Amjad Ali @ Tomba of Lilong Atoukhong Maning Leikai, Thoubal District, Manipur** and arrested him by preparing a formal arrest memo on 04/09/2021 at 04:50 p.m. from the spot i.e., Lilong Haoreibi Turel Ahanbi Ubakthong Makha near Idigah along Idigah Road.

In the meanwhile on received of a call on the mobile phone of Md. Mujibur it come to know that the unknown individuals who gave the illegal drugs to Md. Mujibur were waiting for him in front of Lilong Bazar Oil pump along NH-102 to collect the money of illegal drugs handed over to him. Accordingly, I along with my team and a team of Lilong PS including lady police and Shri. Sachidananda Soibam, MPS Addl. SP(Ops)/Thoubal immediately rushed at Lilong Bazar oil pump along NH-102. On reaching there one Bolero B/Regd. No. NL03-2267 white in colour was seen parked in the front of Lilong Bazar oil pump in a very suspicious manner and one male and one woman were found seated in the vehicle. On preliminary verification, they identified themselves as 1) Deineihoi Haokip 25 yrs. W/O Hemminson Haokip of Moreh Ward No. 2, Tengnoupal District, Manipur and 2) Minlon Tuboi (37) yrs. S/o Jangpou Tuboi of Moreh Ward No. 9, Tengnoupal District, Manipur. Then, they were offered to search their body in presence of Gazetted police officer or Magistrate. In that they opted to search their body in presence of Gazetted police officer. On searching the body of Deineihoi Haokip 25 yrs. W/O Hemminson Haokip of Moreh Ward No. 2, Tengnoupal District, Manipur in presence of Shri Sachidananda Soibam, MPS, Addl SP(Ops)/TBL as Gazetted Police Officer witness by a lady police one MI Redmi Note 9 mobile phone handset with one AIRTEL SIM card bearing mobile no. 7085485889 was found from her possession and on searching the body of Minlon Tuboi (37) yrs. S/o Jangpou Tuboi of Moreh Ward No. 9, Tengnoupal District, Manipur one OPPO F52 mobile phone handset with one AIRTEL SIM card bearing mobile no. 8413010731 and one vehicle key was found from his possession respectively. On further verification, they disclosed that they were waiting for Md. Mujibur for collecting money of illegal drugs (i.e., Heroin powder) which was handed over him today.

Finally, one OPPO F52 mobile phone handset with one AIRTEL SIM card bearing mobile no. 8413010731 and one Bolero B/Regd. No. NL03-2267 white in colour were seized by preparing a formal seizure memo on 04/09/2021 at 05:40 p.m. from the possession of **Minlon Tuboi (37) yrs. S/o Jangpou Tuboi of Moreh Ward No. 9, Tengnoupal District, Manipur** and arrested him by preparing a formal arrest memo on 04/09/2021 at 05:45 p.m. from the spot i.e., at the front of Lilong Bazar Oil Pump along NH-102. Then, also one MI Redmi Note 9 mobile phone handset with one AIRTEL SIM card bearing mobile no. 7085485889 were seized by preparing a formal seizure memo on 04/09/2021 at 05:50 p.m. from the possession of **Deineihoi Haokip (25) yrs. W/O Hemminson Haokip of Moreh Ward No. 2, Tengnoupal District, Manipur** and arrested her by preparing a formal arrest memo on 04/09/2021 at 06:00 p.m. from the spot i.e., at the front of Lilong Bazar Oil Pump along NH-102.

The arrested accused persons along with the seized articles are handed over to you for taking further necessary legal action against them.
