

Subject:- Report

Sir,

I have the honour to report that today i.e. 13/09/2021 at about 6.00 pm I along with my police party were conducting frisking and checking of suspected person at Lilong Suptu Karong in order to detect movement of anti-social element under the supervision of Superintendent of Police, Thoubal. While conducting frisking and checking, one unknown person was seen moving hurriedly in a suspicious manner. On seeing the police team, the unknown person try to fled away but he was overpowered and detained for verification. On spot verification, he identified himself as Thoubalmayum Ali @ Aliba (34) S/O Th. Indraman of Phundrei Makha Leikai. On searching the body, the police team found one soap cap containing of suspected Heroin weighing 23.64 including the weight of plastic container. So the above suspected Heroin was seized by preparing a formal weighing and seizure memo from the possession of Thoubalmayum Ali @ Aliba (34) S/O Th. Indraman of Phundrei Makha Leikai on 13/09/2021 at about 6.30 pm and arrested the accused person Thoubalmayum Ali @ Aliba (34) S/O Th. Indraman of Phundrei Makha Leikai by preparing formal a arrest memo on 13/09/2021 at about 6.50 pm in presence of witnesses by observing formalities.

The arrested person along with seized items are handed over to you for taking further necessary legal action against him.
