Sir,

I have the honour to report that today i.e. 15/09/2021 at about 01:10 am, while I was in my office one of my source man appeared at my office and informed me that one individual namely Buyamayum Shahabuddin (31) yrs, S/o. Buyamayum Kayamuddin of Hiyangthang Pallak and his associates is loitering in an around Lilong Arapti Lamkhai Inter Village Road for supplying illegal drugs. After verifying the veracity of the source report, the information was taken down in writing and a copy of the same was forwarded to Officer in-Charge, Lilong Police Station. Accordingly, I obtaining searched authorization from Superintendent of Police, Thoubal. Immediately, I along with my team led by OC/LIL-PS including woman police, a team of CDO/TBL led by Jem. Amin Khan and a team of Porompat PS under guidance of OC/PRT-PS and team of Youth Athletic Development Association (YADA) including source man under the supervision of Shri. Sachidananda Soibam, MPS Addl. Superintendent of Police (Ops)/Thoubal and under the overall supervision of Shri. Jogeschandra Haobijam, IPS, Superintendent of Police, Thoubal District, Manipur rush towards Lilong Arapti Lamkhai Inter Village Road. On reaching the spot, our police party saw one person loitering there and on seeing the police party he managed to escape from the spot but he was overpower and detained for verification.

On preliminary verification, he identified himself as Buyamayum Shahabuddin (31) yrs, S/o. Buyamayum Kayamuddin of Hiyangthang Pallak. Then, he was offered to search his body and belonging in presence of Gazetted police officer or Magistrate. In that he opted to search his body and belonging in presence of Gazetted police officer. Accordingly, I informed Shri. Sachidananda Soibam, MPS Addl. Superintendent of Police (Ops)/Thoubal to be witness on searching the body of Buyamayum Shahabuddin 31yrs S/o Buyamayum Kayamuddin of Hiyangthang Pallak. On searching the body in presence of Shri. Sachidananda Soibam, MPS Addl. Superintendent of Police (Ops)/Thoubal as Gazetted Police Officer witness including woman police, the police team found one Oppo mobile phone handset bearing IMEI 1: 863782055456437 & IMEI 2: 863782055456429 from the possession of accused person namely Buyamayum Shahabuddin 31yrs S/o Buyamayum Kayamuddin of Hiyangthang Pallak. Further, on searching of his belonging of black colour polythene, the police team detected 45(forty five) nos. of soap caps which contained of suspected Heroin powder inside plastic packets. All the plastic packets containing suspected Heroin powder were marked as P1, P2, P3, P4, P5, P6, P7, P8, P9, P10, P11, P12, P13, P14, P15, P16, P17, P18, P19, P20, P21, P22, P23, P24, P25, P26, P27, P28, P29, P30, P31, P32, P33, P34, P35, P36, P37, P38, P39, P40, P41, P42, P43, P44 & P45 respectively and on weighing (1) 11.7 grams in P1, (2) 12.2 grams in P2, (3) 12.7 grams in P3, (4) 11.8 grams in P4, (5) 12.4 grams in P5, (6) 11.5 grams in P6, (7) 12.6 grams in P7, (8) 12.5 grams in P8, (9) 11.8 grams in P9, (10) 12.8 grams in P10, (11) 10.8 grams in P11, (12) 10.4 grams in P12, (13) 12.7 grams in P13, (14) 14.4 grams in P14, (15) 11.6 grams in P15, (16) 13.7 grams in P16, (17) 12.4 grams in P17, (18) 12.4 grams in P18, (19) 12.3 grams in

Finally all the exhibits i.e., suspected Heroin powder including mobile phone, were seized by preparing a formal weighing and seizure memo on 15/09/2021 at 02:30 am from the possession of Buyamayum Shahabuddin 31yrs S/o Buyamayum Kayamuddin of Hiyangthang Pallak and also arrested him by preparing a formal arrest memo on 15/09/2021 at 02:50 am from the spot i.e. Lilong Arapti Lamkhai Inter Village Road.

The arrested accused person along with the seized articles was handed over to you for taking further necessary legal action against him.
