In fact, I am illiterate. For the purpose of appropriate legal action, I am herewith filing a copy of the agreement dated 24.3.2019 which contains my forged signature. As stated, I

am totally illiterate. Hence, the said agreement is a forged one. Copy of which is herewith enclosed.

I, therefore, request you kindly to take immediate appropriate legal action against said Sheikh M Bahauddin.
