With reference to the above subject I, the undersigned have to report you that I am the proprietor of M/S EREICHA INDANE GRAMIN VITRAK being Lic. No. 5/35/DC//TbI/FCS/2018 located at Lilong Chingkhram Mamang the respect of cooking Gas.

That, the above named accused no. 1 is my father, accused no. 2 & 3 are my brothers. The accused no. 1 to 3 are working\employed in my said agency\office on payment of monthly salary. I handed over all the keys of the godown and showroom to accused persons for running my said bussiness. The accused no.1 is working as casheir cum accountaint and he is responsible for account purposes. The accused no.2 is working as caretaker and accused no.3 is working as incharge of home delivery to the consumer of the said agency.

That, the said accused persons had not opened the said office for delivery of gas to the consumers and on my inquiry, it is known to me that the accused persons had stolen some gas cylinders and concealing at unknown places. They also did not come in the said office since some days back. The accused persons also had not returned to their respective place of residence. In short, the accused persons have been hiding in/at unknown place since some days back. With holding/possessing all the keys of the showroom & godown of my gas agency. Moreover, My vehicle Maruti super carry bearing registration no. MN01AA2618 which is used for home delivery of gas cylinders to the consumer also kept concealing at unknown place by the accused persons.

That, on the pressors of consumers of my said agency on 3/9/2021 at about 9am I along with some of my friends tried to open the said godown and showroom for delivery of the gas to the consumers. The accused persons alongwith four unknown persons rushed to my said office by holding deadly weapons such as iron rod, hockey stick, spade etc. in their hands and attempted to kill me. The accused persons threaten my life and not to open said godown. I made hue and cry for help. On hearing my hue and cry, some rushed to the spot and saved my life.

That accused persons warned me no to report the matter to any authority including police. Otherwise, they will kill me at any point of time.

That it is also came to know that accused no. 4 also actively involved in the commisionof the crime as the criminal action of the above mentioned three employees/accused persons has been committed under the instruction/instigation of the said accused no. 4.


So, I am requesting you to take the necessary legal action U/S-380/307/452/120B against the accused persons as soon as possible.
