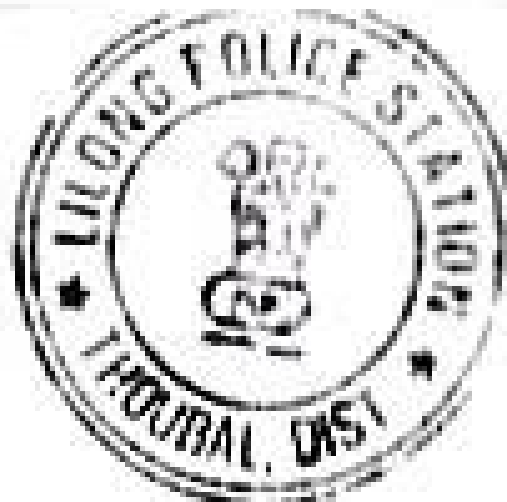

Subject:- Report

Sir,

I have the honour to report that today i.e. 03/10/2021 at about 12.30 am I along with my party were conducting frisking and checking of suspected person and round patrolling in and around Lilong area in c/w visit of Hon,ble Vice President of India to Manipur on 05/10/2021 in order to prevent from untoward incident under the supervision of Additional Superintendent of Police (Ops), Thoubal and under the overall Supervision of Police, Thoubal. While conducting frisking and checking at Lilong Nungei Turei Machin Ningthikhong at about 1.30 am, one unknown person was seen riding one two wheeler vehicle towards Lilong Nungei in a suspicious manner in high speed. On seeing the police team, the unknown person was trying to divert the vehicle U-turn towards back side but the unknown person was overpowered at the spot.

On spot verification, the unknown person identified himself as Singamayum Nahamu (31) S/O S. Kanden of Irong Khunou. On checking the vehicle Honda Dio bearing No. Nil detected one sack bag light green in colour containing of suspected Brown Sugar (Heroin) (remnant of manufactured brown sugar) and found to be weighing 37.6 Kg when weighed by weighing balance including the weight of sack bag. On further searching the body, found one mobile phone handset MI 6A bearing mobile no. 8787625522. So, the above suspected Brown Sugar (Heroin) (remnant of manufactured brown sugar) including mobile phone handset and Honda Dio bearing No. Nil were seized by preparing a formal weighing and seizure memo on 03/10/2021 at 2.00 am from the possession of Singamayum Nahamu (31) S/O S. Kanden of Irong Khunou and arrested the accused person Singamayum Nahamu (31) S/O S. Kanden of Irong Khunou by preparing a formal arrest memo on 03/10/2021 at 2.10 am.

On preliminary examination of accused Singamayum Nahamu, he stated that the above suspected Brown Sugar (Heroin) (remnant of manufactured brown sugar) was taken from one Yumkhaibam Rajib Khan (27) S/O Y. Anjob Ali of Irong Echin Mathak. Accordingly, informed volunteer members of Irong Mathak Development Committee, Irong Chesaba and Youth Athletic Development Association, khergao and rushed towards the house of Yumkhaibam Rajib Khan (27) S/O Y. Anjob Ali of Irong Echin Mathak and found at his residence. So, Yumkhaibam Rajib Khan (27) S/O Y. Anjob Ali of Irong Echin Mathak was arrested by preparing a formal arrest memo on 03/10/2021 at 3.10 am and seized one mobile phone handset Cellector bearing mobile no. 9378117633 by preparing a formal seizure memo on 03/10/2021 at 3.20 am.

The arrested person along with seized items are handed over to you for taking further necessary legal action against them.
