

Sir,

I have the honour to report that my nephew namely Md. Rahish Khan aged about 16 years went out from my house located at Lilong Sangomsang Suptu Karong for West Bengal along with one Md. Mubarak 40yrs S/o Unknown of Malda District, West Bengal since 04/09/2021 at about 12.00pm for purchasing a four wheeler vehicle. However, he did not returned back at home till date. I am unable to trace out his whereabouts till date in spite of vigorous search. He was carrying mobile phone bearing mobile no. 7629943792, but his mobile phone is also remained in switch off. In the meanwhile, some unknown persons threatened me through mobile phone that they had kidnaped my nephew namely Md. Rahish Khan and detained/wrongfully confines at Kaliachak area of west Bengal. The said unknown persons also demanded to pay sum of Rs. 15,00,000/- (Rupees Fifteen Lakh) for releasing my said nephew from their custody and also threatened me for causing death or grievous hurt of my said nephew in case of their demand amount is paid immediately.

His physical descriptions are as follows: Height-5 feet 3 inches; Complexion-Black; Face-elongated; Hair-black and short; Body- thin; Eye-black.

Wearing apparatus: One Black colour T-Shirt, one Black colour jeans long pant and white colour shoes.

It is therefore requested to take up necessary action and to trace out/rescue my nephew at the earliest and taking necessary legal action against the unknown culprits.
