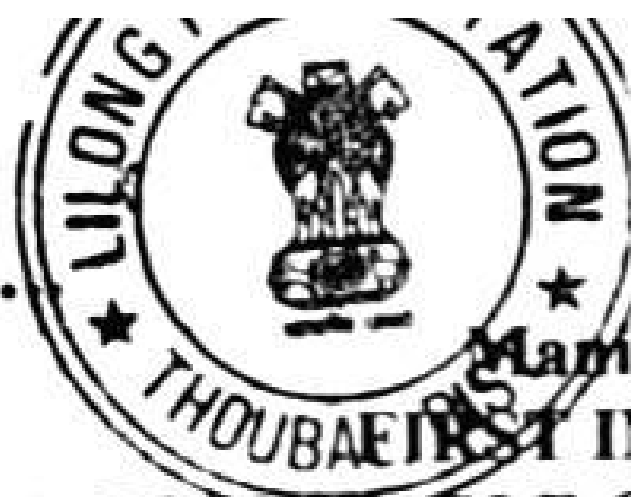

Sir,

I have the honour to report that today i.e. 11/10/2021 at about 06:30 pm while I along with my team of Lilong PS assisted by SI. Md. Isha Khan of Lilong PS were conducting normal patrolling duty in and around Lilong Chingkhram Kabui and Lilong Ubakthongthong area under the Supervision of Shri. Jogeschandra Haobijam, IPS, Superintendent of Police, Thoubal District, Manipur. In that, while we are conducting patrolling at Lilong Haoreibi Turel Ahanbi Ubakthong Makha we seen one unknown individual who was standing near a parked Scorpio vehicle at Lilong Haoreibi Turel Ahanbi Ubakthong Makha IVR. On seeing his suspicious manner the police party immediately chased upon the said individual in order to detain him for verification but he was managed to escape from the spot by taking the advantage of darkness. However on identification of the parked Scorpio vehicle its registration No. is AS01BN-4396. On searching the Scorpio vehicle bearing Regd. No. AS01BN-4396, the police team found two gunny bags and on opening the two gunny bags found 815 (eight hundred fifteen) nos. of "KOF-T" cough syrup containing Chlorpheniramine Maleate and Codeine Phosphate syrup of 100 ml capacity. Attempt have been made to identify the owner of the seized drugs but in vain.


Finally the exhibits was seized by preparing a formal weighing and seizure memo at 08:10 pm by observing formalities.
