

With due respect I have the honour to state that on 30/10/2021 at about 1.00pm while I along with my father namely Md. Basir Ahmad 70yrs S/o Late Md. Bashiruddin of Lilong Bazar were standing at Lilong Bazar near NH/102, the above noted accused persons pelted bricks towards us from the floor of accused no. 1 and they also assaulted us by using iron rode. As a result of which I along with my father received bleeding injuries on our persons and evacuated to hospital for medical treatment. However my father received serious bleeding injury.

It is therefore requested to kindly take up necessary legal action against the above noted accused persons.
