Respected Sir,

I have the honour to state a few words for your kind perusal and immediate necessary action as follows:-

That, on 30.10.2021 at about 12.30 p.m. the above named accused persons forcibly entered inside the our homestead land under patta No. 796 Part (old); 867/2160 (new) covered by C.S. Dag No. 28/258 measuring .0568 hect. situated at Village No. 16 - Lilong under Lilong Sub Division which is recorded in the name of my husband namely Md Habibur Rahaman 68years S/o Late Md. Bashiruddin of Lilong Bazar. The above named accused persons tried to construct a kutcha shed inside said land. I along with my husband including his sisters resisted their illegal acts and not allowed them to construction of the said kutcha shed inside my homestead land. There were exchange of some hot words, suddenly the above name accused persons assaulted my husband including his sisters namely 1) Jubeda, 2) Sanahal, 3) Jumera. Further the accused persons warn us to face dire consequences. It seems that the said illegal acts were done at their own risks by the accused persons in order to take the homestead land involved in the Original Suit being No. 37 of 2021 now is pending before the Civil Judge Junior Division Thoubal filed by my husband against Accused person No. 1.

That, therefore your good self be kind enough to take stern action against the accused persons otherwise there is imminent breach of peace and bloodshed may occurred at any moment inside patta land.
