Today i.e. 30/10/2021 at 8.00pm received an information that some unknown villagers numbering about 400/500 were formed an unlawful assembly and they also conducting a rally along the inter village road of Lilong Turel Ahanbi area without obtaining permission from the concerned authority. It is further revealed that the individuals who were participating in the said rally also organized publicity campaign with using loud speaker by hatred words which may create disharmony or feelings of enmity among different cast/communities or promoting enmity between different groups which is likely to disturb the peace and tranquility of general public. On the strength of the information Lilong PS teams including women police led by me immediately rushed at the said area and confronted with the rally team along IVR of Lilong Turel Ahanbi near Turel Ahanbi Dam and it is learnt that the rally was organized by ANJUMAN, Lilong and Two Brothers Computer group, Lilong Dam.

The rally team did not disperse the unlawful assembly in spite of repeated instruction/warning has been given to disperse themselves from the unlawful assembly. Since there is no other alternative option the rally team/unlawful assembly was disperse and controlled the unruly mob by our police team with the mild force at about 09.00pm of 30/10/2021. However there was no any causality/damaged on both parties. -

Hence, a suo-motto case under FIR No. 103(10)2021 LIL-PS U/s 142/143/153-A IPC has been registered for investigation.
