Sir,

I the undersigned, the above named Applicant have the honour to report you that, on 05/08/2021 at about 6.30pm, my elder sister Mrs. Meherjan was beaten up by her husband (Accused No.1) in presence of the Accused No. 2 & 3 (his father and mother) and due to serious injury, they had taken my sister to Dr. Najir's Clinic located at Lilong Ushoipokpi on 06/08/2021 at about 8.00pm. The said doctor gave her first aid treatment but due to serious condition of her injuries particularly on the head, we had taken her to RIMS Hospital after we were informed by the neighbours of the accused persons. After admitted to the RIMS Hospital,

the security personnel of the RIMS Hospital had recorded an MLC No. 21/2765(B) but we did not formally report to your office since the actual reason behind her injury was not known to us as she fails to disclose to us at the beginning. Very unfortunately, on 02-11-2021 my sister disclosed to us stating that she was brutally and mercilessly beaten up by her husband by using bamboo stick and Iron Rod on the advice and influence of his parents. Due to head injury, my sister had undergone surgery for Burr hole & evacuation of hematoma / L.A. on 02-11-2021 at RIMS Hospital and she is now keeping in ICU after operation. Her condition is very critical and still unconscious. On the other hand, her husband (Accused No. 1) or any of his family members did not visit the Hospital till date. In fact, their intention was to kill my sister.

It is, therefore, requested your good self may kindly be taken up necessary legal action by registering an FIR case against the undernoted accused persons for committing the above referred offences against the above named victim at the earliest in the interest of justice.
