I have the honour to state that today i.e. 23/11/2021 at around 05:30pm, while I was returning home along with my friends namely Md. Safiqur Rahman 26yrs of Lilong Mairenkhun and Hafiz Aziz 26yrs of Lilong Khunou along the IVR of Lilong Haorou Hangamthabi on a four wheeler vehicle ALTO K10 bearing registration no. AP31DN/7021, driven by me. Suddenly, the above noted accused persons stopped my vehicle near the gate of Ex-councilor Md. Abdul Barik of Lilong Haorou Hangamthabi without any reason, they assaulted me by holding stone, wooden stick etc. As a result of which, I received injuries on my persons and evacuated to Hospital for medical treatment.
