As I am a poor and old man, an unable go to Mohammad Rayish, Near Hotel Habib-e-Darbar, Lilong Uku, Near Petrol Pump, Thoubal, Manipur-795130 personally to lodge complaint.


Therefore, I humbly request before you to recover my son Asrafu Mia and take necessary legal action against those culprits.


