Sir,

I have the honour to report that today i.e., 14/01/2022 at about 04:30 pm while I was in my office one of my source man appeared and informed me that (1) Md. Faroque (35) yrs. S/o Md. Zanulabuddin of Lilong Ushoipokpi Sangomsang and (2) Md. Imtiyas Khan (30) yrs. S/o Md. Zaheruddin of Lilong Ushoipokpi Sangomsang were staying at the house of Md. Imtiyas Khan located at Lilong Ushoipokpi Sangomsang and illegal drugs i.e., suspected to be WY-tablets were kept concealed by them for selling purpose. Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to Officer in Charge, Commando Unit, Thoubal. Accordingly, I obtained searched authorization from Superintendent of Police, Thoubal. Then, I along with my team assisted by Hav. Kamal Hassan of CDO unit, Thoubal and a team of SI. Md. Isha Khan of Lilong PS and led by Inspector N. Tikendro Meitei Officer-in-Charge Commando Unit, Thoubal with necessary equipment under the supervision of Shri. Okaramcha Wangkhomba, MPS Addl. SP(Ops)/Thoubal and under the overall supervision of Shri. Jogeschandra Haobijam, IPS, Superintendent of Police, Thoubal District, Manipur and source man with necessary equipments rushed at the house of Md. Imtiyas Khan (30) yrs S/o Md. Zaheruddin of Lilong Ushoipokpi, Sangomsang.

On reaching the spot, the source man indicates the house (which was kept concealed suspected to be WY-tablets). Our police party cordoned the said house and found two persons inside the house and they are detained for verification. On verification, they identified themselves as (1) Md. Faroque (35) yrs. S/o Md. Zanulabuddin of Lilong Ushoipokpi Sangomsang and (2) Md. Imtiyas Khan (30) yrs. S/o Md. Zaheruddin of Lilong Ushoipokpi Sangomsang. Afterwards, I offered them whether they would want their bodies and belongings and house to be searched in the presence of civil witnesses or Gazetted officer or Executive Magistrate. In that, they offered to search their body and belongings in presence of a Gazetted officer as witnesses. Accordingly, I informed Shri. Okaramcha Wangkhomba, MPS Addl. SP(Ops)/Thoubal to be witness during searching the body and belongings of the above individuals. On searching, their bodies in presence of Shri. Okaramcha Wangkhomba, MPS Addl. SP(Ops)/Thoubal as Gazetted Police Officer witness, one JIO LYF mobile handset with 1 (one) JIO sim card bearing mobile number 9366458394 was found from the possession of Md. Faroque and one Samsung mobile handset with 1 (one) Airtel sim card bearing mobile number 9856936125 was found from the possession of Md. Imtiyas Khan. Further, on preliminary interrogation Md. Imtiyas Khan disclosed that they kept the WY-Tablets inside his (Md. Imtiyas Khan) bed room. On further searching, inside the bed room of Md. Imtiyas Khan and the exhibits have been marked as A1, A2, A3, A4, A5, A6, A7, A8, A9, A10, A11, A12, A13, A14, A15, A16, A17, A18, A19, A20, A21, A22, A23, A24, A25, A26, A27, A28, A29, A30, A31, A32, A33, A34, A35, A36, A37, A38, A39, A40, A41, A42, A43, A44, A45, A46, A47, A48 and A49 for identification.

Finally the exhibits containing JIO LYF mobile handset with 1 (one) JIO sim card bearing mobile number 9366458394 was seized by preparing a formal seizure memo on 14/01/2022 at 05:10 pm from the possession of accused Md. Faroque (35) yrs. S/o Md. Zanulabuddin of Lilong Ushoipokpi Sangomsang and the exhibits containing of the said illegal drugs i.e., suspected WY tablets and one Samsung mobile handset with 1 (one) Airtel sim card bearing mobile number 9856936125 were seized by preparing a formal weighing and seizure memo on 14/01/2022 at 05:20 pm from the unauthorized possession of accused Md. Imtiyas Khan (30) yrs. S/o Md. Zaheruddin of Lilong Ushoipokpi Sangomsang respectively and arrested the accused persons (1) Md. Faroque (35) yrs. S/o Md. Zanulabuddin of Lilong Ushoipokpi Sangomsang, (2) Md. Imtiyas Khan (30) yrs. S/o Md. Zaheruddin of Lilong Ushoipokpi Sangomsang by preparing formal arrest memo on 14/01/2022 at 05:25 pm and 05:30 pm respectively from the spot by observing formalities.

The two arrested person along with seized items are handed over to you for taking further necessary legal action against them.
