

Sir,
I, the undersigned, am the Head Master Haoreibi Mayai Leikai Upper Primary School. which is located at Lilong Haoreibi Mayai Leikai. The school remain closed since the Govt. issued an order for closing of schools due to Pandemic Covid-19.

Today, the 25th Jan. 2022 at about 9.30 am we the staff-members come to school for making preparation on the Promotion of Students, found that rice grains are strewn in and around the gate, but the lock of the gate remain intact. On opening the gate, we find that the door-lock's (L-draw) is broken and rice grains are strewn. When the door is opened, one LED TV and 3 bags of rice (50kg) are stolen away.

The approximate value of the stolen items is Rs 50,000/- (Rupees fifty thousand).

So, it is therefore requested to take up necessary legal action against the miscreants and recover the said stolen items at the earliest.
