Subject: Report.

Sir,

I have the honour to report that my husband namely Md. Abdul Noor aged about 35 yrs went out from my cousin brother house (where we had been residing at the house of Md. Abul Kalam Syed, S/o. Md. Abdul Gani of Lilong Haoreibi Turel Ahanbi since 1 year) for West Bengal along with one Antarun @ Jamal aged about 40 yrs of Palashi Village District- Nadia, West Bengal since 07/12/2021 at about 11:20 am for purchasing a four wheeler vehicle. However, he did not returned back at home till date. I am unable, to find his whereabouts in spite of several attempts. He had carried a mobile phone bearing mobile No. 8258905494 but his mobile phone is also remained switch off. In between, some unknown person had threatened me through mobile phone that they had abducted my husband mention above at Palashi Village area District- Nadia, West Bengal. The said unknown persons also demanded to pay a sum of Rs. 18,00,000/- (Rupees eighteen lakh) for releasing my husband from their custody and also threatened me for causing death or grave injury to my husband in case, of their demand, not being paid in time.

His physical descriptions are as follows: i) Height- 5 feet 5 inches, ii) Complexion- Wheaties, iii) Face- Oval, iv) Hair- Black and short, v) Body- Thin & vi) Eye- Black.

Wearing apparatus: i) One black colour jacket, ii) One blue colour long pant and iii) white colour shoes.

It is therefore requested to take up necessary action and to trace out/rescue my husband at the earliest and take necessary legal action against the unknown culprits.
