



Today i.e. 14/02/2022 at 23:15 hrs received an information that on the same day at around 22:57 hrs, some unknown persons numbering about 100 plus were assembled and formed an unruly mob in the Lilong Bazar area near SBI Lilong Branch along NH-102. The unruly mob turn violent and had partly damaged 04(four) nos. of four wheeler vehicles. Acting on the information, Lilong Police team led by me and CDO/TBL teams stationed at Lilong PS rushed to the said area and started controlling the unruly mob. Immediately SP Control room Thoubal, was informed about the incident taking place. Thereafter additional teams arrived at the spot and further dispersed the mob.

Hence a suo-motto case has been registered under FIR No. 13(02)2022 LIL-PS U/s 147/148/149/427 IPC for investigation of the case.
