Sir,

Most respectfully, I, the undersigned, have to state the following few lines for your timely action in the matter under reference:

That, on 26/01/2022 at about 02:30 p.m. while my son, namely Md. Taj Ahmed @ Nanao (25) was going to Leihaokhong Mamei, Lilong in a Maruti Alto Car for his personal work, he was detained on the way at Leihaokhong Mamei, Lilong by the above named 6 culprits, forcibly with a view to extort and personal belonging by holding deadly weapons, like, heavy stick, iron rods, etc. without any cogent reason.

After taking my said son and his Maturi Alto Car in their custody, he was kept confining in the house of Md. Jamaluddin (Culprit No. 5) and brutally tortured by them, above named, causing serious injuries all over the body.

Having learnt the information of such illegal acts, a report was immediately made to this office i.e. Office of the Officer-in-Charge, Lilong Police Station at about 04:00 p.m. and after receiving the report your personnel acted upon immediately and rescued my victim/son along with his personal belongings including the vehicle Alto car bearing Registration No.MNO-5-6609.

My son was evacuated to the hospital by your personnel in the evening and medically treated for seriously injured body and he was discharged only on 27/01/2022 in the morning with an advice to underdo strict medical care and treatment.

The said above named culprits are still at large, and in the meantime, it is also informed to my family members that the said culprits, who are of a same family and locality are looking for us the moment of attacking my family, wherever they find and meet us.

On 3-12-2021 at about 8:00 a.m. I was also assaulted after detaining me at the house of Md. Tahir, the culprit No. 1, along with his sons by using deadly, weapons. However, I was rescued by the local people in time. But, I did not file any report to the police with a view to settle the matter amicably. At the time of releasing me on that day, a sum of Rs. 50,000/- (Fifty Thousand Rupees) only was also robbed from me by the culprits.

In the facts and circumstances stated above, your good self may be pleased to look into the matter and punish the all organized gang members, named above, so as to avoid further bloodshed and loss of life in near future, in the interest of justice.
