

Sir,

With due respect, I am to state that on 20/04/2022 at 11:20 am complainant namely Dolaipabam Sadiq Khan 32 yrs S/o. Md. Nawab Khan of Lilong Haoreibi Makha Leikai reported to OC/LIL-PS regarding missing of one Dolaipabam Babul Hadi @ Baboy aged about 20 years, S/o. Md. Nawab Khan of Lilong Haoreibi Makha Leikai Zarima Salam. On receipt of the report an enquiry has been initiated vide GD Entry No. 18/LIL-PS dtd 20/04/2022 and endorsed to me for further enquiry.

During the course of inquiry, I have sent out hue and cry message to all OCs/PSs in Manipur and examined PWs in c/w the inquiry. On preliminary enquiry it has been confirmed that on 17/04/2022 at about 06:30 am, the missing person namely Dolaipabam Babul Hadi @ Baboy has left home along with Yumkhaibam Abas Khan aged about 27 yrs, S/o. (L) Yumkhaibam Karimuddin of Lilong Haoreibi Makha Leikai Lairakhong and his brother namely Md. Amir Khan from the house of Dolaipabam Babul Hadi @ Baboy i.e. Lilong Haoreibi Makha Leikai Zarima Salam. However the missing person could not be traced out till date. It is highly suspected that the above noted missing person namely Dolaipabam Babul Hadi @ Baboy was kidnapped from nearby his house by Yumkhaibam Abas Khan, S/o. (L) Yumkhaibam Karimuddin of Lilong Haoreibi Makha Leikai Lairakhong along with his brother namely Md. Amir Khan and kept confined in an undisclosed location. So, Yumkhaibam Abas Khan and his brother Md. Amir Khan is highly required to be arrested in c/w the enquiry.

It is therefore submitted the enquiry report for favour of taking further necessary legal action.
