

Subject: - Report.

Sir,

I have the honour to report that today i.e., 25/04/2022 at about 4:20 pm received a reliable information regarding presence of some stolen vehicles in and around Lilong Tairen Makhong areas. Acting on the information, a team of CDO-IW under the supervision of M. Amit Singh MPS, ASP (Ops) IW rushed to the said area after giving prior information to Thoubal Police control room and found one suspected youth standing near a Honda Activa at Lilong Tairen Makhong near ITI Road in a suspicious manner. Immediately our team detained the youth for spot verification and found that the youth was riding the said Honda Activa 5G red in colour bearing registration no. MN01AJ/0358. On spot body search, one Redmi note 8 model no. M1908C3JI along with one Airtel SIM card bearing SIM card No. H10521EC8991160990017273372U (Ph.No. 8798530854 as disclosed by him), one wallet black in colour containing Rs. 250/- (two hundred fifty only) and one Aadhaar card were found from his possession.

On spot verification he identified himself as Md. Zaid Khan (30 yrs.) S/o. Md. Helaluddin of Lilong Atoukhong Maning Leikai. On further checking the details of the vehicle, he couldn't give any details of the real owner of the vehicle. Instead, he disclosed that the Honda Activa bearing registration no. MN01AJ/0358 which he have possessing is stolen one handed over by M.M. Parsha @ Naoba S/o Ahmallah of Lilong Tairen Makhong and Md. Subas S/o Md. Wahid of Mairenkhum to sell off to one unknown person communicated by M.M. Parsha @ Naoba. Our team detained him while he was waiting at Lilong Tairen Makhong near Oil Pump for the potential buyer. Hence, Md. Zaid Khan was arrested at 5:00 pm from the spot and seized the above recovered articles at 5:10 pm by observing formalities. But as he disclosed that his accomplice namely M.M. Parsha @ Naoba may be around Imphal Bazar area, our team without handing over the arrested PS to concerned person directly came to Imphal as he was required to identify his accomplice.

On reaching North AOC traffic point, our team started looking out for possible vehicles used by M.M. Parsha @ Naoba (19 yrs.). Around 7:00 pm, Md. Zaid Khan identified one silky silver Alto bearing registration No. DL13CA/4220 as the vehicle frequently used by M.M. Parsha @ Naoba. Our teams immediately stop the vehicle and detained the driver. On spot body search, one MI mobile handset model no. M1908C3JI along one Airtel SIM card bearing SIM card no. 8991160990008166129U (Ph.no. 8119992248 as disclosed by him) and one fraud vehicle registration certificate were found from his possession. On further verification, the driver identified himself as M.M. Parsha @ Naoba S/o Ahmallah of Lilong Tairen Makhong, the said accomplice of Md. Zaid Khan. On questioning about the above seized Honda Activa 5G red in colour bearing registration no. MN01AJ/0358, he disclosed the Activa was stolen one given to him by one Md. Subas S/o Md. Wahid of Mairenkhum to be sold off. On checking the silky silver alto driven by him, the document of the vehicle is forged one and the vehicle is stolen one purchased from one unknown person from khumidok side Imphal east. Hence, he was arrested at the spot at 7:20 pm and the above mentioned silky silver alto along with the recovered articles were seized at 7:30 pm from his possession by observing formalities.

Hence, the arrested persons along with seized items are handed over to you for taking further necessary legal action.
