Subject: Report

Sir,

I have the honour to report that today i.e. 02/05/2022 at about 10:50 hrs, a team of Lilong Police Station conducted routine patrolling in and around the area of Lilong Yangbi Leikai under the supervision of Inspector Th. Phulachandra Singh OC Lilong PS.

That, while the team was conducting routine patrolling and checking along the road one Baleno Nexa silky silver in colour Bearing Registration Number AS 01DW 9131 was checked. On being asked and on seeing the confidence nature of the Police team, he identified himself as Buyamayum Hefajuddin (25) yrs S/o Md. Ziauddin of Hiyangthang Pallak P.O & PS- Wangoi, District, Imphal West. While checking the vehicle, 3(three) cartoon (yellow in colour) were found inside the Dicky of the vehicle. On opening the three cartoon boxes 120 numbers of bottles of 100 ml capacity marked as ANREX-CP Chlorpheniramine Maleate & Codeine Phosphate Cough Syrup were found in each box i,e altogether 360 bottles of ANREX-CP cough syrup and further stated that he brought the ANREX-CP cough syrup from one Md.Sabir (29) years S/o Md.Samim of Lilong Yangbi Leikai in order to sell out to some willing buyer for his wrongful gain. Accordingly, (i) 3 (three) cartoon boxes containing 120 nos. each of bottles of ANREX-CP Chlorpheniramine Maleate & Codeine Phosphate Cough Syrup (ii) one Baleno Nexa silky silver in colour Bearing registration Number AS 01DW 9131 (iii) One Mobile Handset OPPO Reno 5G (silver in colour) bearing mobile number 9612701978 (IV) One wallet containing One PAN Card, one aadhar card and a sum Rs 1070 (Rupees one thousand seventy) only were seized at 11:15 hrs from his possession and on his production. It is to mention no one was willing to cooperate to witness the seizure, on being requested.

In the light of the above facts and circumstances, he was arrested at 11:30 hrs. The arrested accused person along with the seized items are therefore handed over to you for taking necessary legal action against him.
