

Subject: - Report.

Sir,

I have the honour to report that today i.e., 09/05/2022 at about 12.00 pm received a reliable information about the presence of one vehicle lifter namely Md. Ziaur Rahman (19 yrs) S/o. Md. Burhanddin of Lilong Khunou near Khunou Masjid. Acting on the information, teams of CDO Imphal West led by myself under the supervision of Shri M. Amit Singh, MPS Addl. S.P. (OPs) IW rushed to the said area after giving prior information to Thoubal District Police Control room and conducted cordon and search operation at Lilong Khunou areas at about 12.50 pm. During the search operation at the house of Md. Burhanddin of Lilong Khunou near Khunou Masjid, one KTM 250 Duke bike was found parked in front of his house and one unknown person also was found hiding in a room in a very suspicious manner. Due to his suspicious manner he was detained for spot verification.

On spot verification, he identified himself as Md. Ziaur Rahman (19yrs) S/o. Md. Burhanddin of Lilong Khunou near Khunou Masjid. On further questioning, he disclosed that he along with his associates namely Md. Ashif @ Mamei S/o. Md. Rashid Ali of Lilong Dam Makha, one Md. Tarique S/o. Md. Karim of Lilong Ubakthong Mathak and one Md. Ajmir S/o. Md. Zakir of Lilong Ubakthong Mathak were involved in stealing vehicles from Imphal West and Imphal East areas. He further revealed that the said KTM 250 Duke bike bearing Regd. No. AS03AD0473 was a stolen one and given to him by his associates Md. Ashif @ Mamei and Md. Tarique. He further disclosed that presently some stolen vehicles are also at the possession of Md. Ashif @ Mamei. Hence, he was arrested at the spot at 01:20 pm and the recovered vehicle was seized at 01:30 pm by observing formalities.

Immediately our team along with arrestee rush to the house of Md. Ashif @ Mamei S/o. Md. Rashid Ali of Lilong Dam Makha and conducted cordon and search operation, but Md. Ashif @ Mamei was not found at his house. While searching the house, one Hyundai Creta white in colour without Regd. No. and one KTM Motorex bike without Regd. No. were found parked in front of the house. On being asked about the owner of the said two vehicles, no one came forward to be the owner of the vehicles. Therefore, the vehicles were suspected to be stolen vehicles. Hence, the said two vehicles were seized at 02:05 pm for further verification.

Immediately, our CDO teams along with the arrestee rushed to the house of Md. Ajmir S/o. Md. Zakir of Lilong Ubakthong Mathak and again conducted cordon and search operation. But Md. Ajmir was also not found at his home and one Honda Dio red in colour without Regd. No. was found parked at the veranda of the house and one loose lock of Scooty. The owner of the said Honda Dio too was unable to identify. Therefore, the Honda Dio too was suspected to be stolen vehicle. Hence, the said vehicle was seized at 02:35 pm for further verification.

The arrested person along with the seized vehicles are handed over to you for taking further necessary legal action against them.
