

PRESS RELEASE
Imphal, the 11th December, 2018



1. On 10/11/2018 at about 10:15 am received a reliable information about the presence of some active cadres of United National Liberation Front (UNLF) an outlawed banned organization are loitering in general area of Keibi area Imphal East, teams of CDO/IW under the supervision of Shri Th. Krishnatombi Singh, MPS, ASP(Ops)IW, after giving prior information rushed to the said area and conducted cordon and search operation at the house of one (L) Sapam Mani Meitei of Keibi Kumuda Maning Leikai. During that one unknown person was detained for spot verification and identification on suspicion. On spot verification, he identified himself as Sapam Shantikumar Meitei @ Manaoton @ Manaotonmacha (45) S/o (L) Sapam Mani Meitei of Keibi Kumuda Maning Leikai. On preliminary questioning, he disclosed that he is an active cadre of UNLF organization and presently he is working under the command of S/S Major Ningtam of UNLF organization. Further, he also disclosed that he had joined the said organization in the year 1993 and completed his military basic training at Chumu Myanmar under army No. 571 of 13th batch of UNLF organization and presently holding the rank of 2nd Lieutenant of UNLF organization. On further questioning, he also revealed that he had threaten to assault and kill the surrendered cadres of underground outfits and their family on the advice of S/S chief of Army Pambeiba @ Mintai of UNLF organization. He was arrested at the spot at 11.45 am by observing formalities.

A case has been registered at Sagolmang Police Station and investigation is going on.

2. In a major break through, Narcotics and Affairs of Border (NAB), Manipur arrested a **Deputy Superintendent of Police (DySP), MPS, TAKHELLAMBAM BANGKABIHARI SINGH** (55). S/o (L) T. Amuba Singh of Uripok Achom Leikai, Imphal West District in connection with Case FIR No. 71 (10) of NAB PS from Uripok Kangchup Road, near Heritage Convent School at 5.15 am on 11/12/2018.

On 28/10/2018 at 4.30 pm, NAB arrested one Khumujam Robindro (46) S/o Kh. Nilakanta Singh of Mayang Imphal Konchak Makha Leikai, Imphal West District along with 2 (two) kgs of Heroin Brown Sugar. During the course of investigation, the accused Kh. Robindro Singh who is now in judicial custody disclosed that he received information that his friend Inspector Bangkabihari had some kilos of heroin brown sugar with him at Jiribam PS. They had several meetings at Jiribam and Imphal after the confirmation of the drugs in the possession of Bangkabihari. Later, Bangkabihari brought the drugs and delivered two (2) kilos of heroin brown sugar to Khumujam Robindro at his residence in Mayang Imphal on 16/10/2018 for disposal. Khumujam Robindro was arrested with the two (2) kilos of heroin brown sugar from Konung Mamang on 28/10/2018.

DySP (MPS) Bangkabihari is presently posted in Special Investigation Team (SIT), Manipur.
