

**PRESS RELEASE**  
Imphal, the 13<sup>th</sup> November, 2018



1. Yesterday, on 12/11/2018, a combined team of Narcotics and Affairs of Border (NAB) and Thoubal Police led by Addl SP Th. Brinda under the supervision of NAB SP and Thoubal SP seized 15,500/- (fifteen thousands) nos of Pseudoephedrine tablets from the residence of Md. Ramijuddin @ Rami, of Lilong and 98,000/- (ninety eight thousands) nos of WY tablets from the house of Mrs. Bibi Eisha (60 years) of Lilong belonging to Md. Zabir Ahamad of Lilong. Following items have been seized in c/w the case: (1) A Maruti A-Star Car bearing registration no AS01AK 6584 (2) Rs 3100/- (three thousands one hundred) and several incriminating articles.

The locality organized a violent mob and obstructed the police team while conducting the raid. Further, with reinforcement from Thoubal Police, a cordon and search operation of the area was conducted. Altogether, four persons have been arrested in connection with the case: 1) Mrs. Amina (45), w/o Md. Jamaluddin of Lilong Chingkhong Makha, 2) Mrs. Samim (35), w/o Serajjurahaman of Lilong Turel Ahanbi Kaleikhong Makha, Ubakthong Mathak, 3) Mrs. Akebi (40), w/o Md. Anwaruddin of Lilong Turel Ahanbi Kaleikhong Makha, Ubakthong Mathak and 4) Mrs. Lalijan (35), w/o Md. Rafik of Lilong Turel Ahanbi Kaleikhong Makha, Ubakthong Mathak.

The price of the seized drugs at International market is Rs 4,93,25,500/- (Four crores Ninety-five lakhs Twenty-five thousands and five hundred).

The whole operation was conducted with active support of All Lilong Anti-Drug Association (ALADA) and Anjuman Islahi Mua-Sarrah.

An FIR has been registered at NAB-PS and investigation is going on.

2. On 11/11/2018, at 12:25 pm, on received of a reliable information a team of District Police Commando, Imphal East conducted cordon and search operation at in and around Seijang area, Imphal East District. During the cordon and search operation one active member of KCP (Maoist) namely R.K. Aboysana Singh @ Aboy (21 years) S/o (L) R.K. Milan Singh of Seijang Mayai Leikai was arrested.

A case has been registered at Yaingangpokpi Police Station and investigation is going on.

3. On 11/11/2018, at 1:45 pm, on received of a reliable information a team of District Police commando, Imphal East conducted search operation in and around Hatta Golapati area, Imphal East District. During the search operation one active member of UNLF namely Md. Siraj Khan @ Sahid @ Warish (21 years) S/o (L) Helaruddin of Sora Karanchi A/P Hatta Golapati under army no. 2447 of 42<sup>nd</sup> Batched was arrested.

A case has been registered at Porompat Police Station and investigation is going on.
