

PRESS RELEASE

Imphal, the 14th December, 2018

1. On 13/12/2018 at about 01:00 am, on receiving a reliable information about the presence of KYKL cadres in the general area of Yaripok Laimanai area, Commandos of District Police, Thoubal rushed to the area and conducted search of a rented house which belong to Moirangthem Sanjit Singh, 27 yrs, S/o M. Surchandra Singh of Yaripok Laimanai. During the search, one suspected person was found and he was detained for verification. On examination, he identified himself as Phoujabam Lukhoi Meitei @ Sagar (19) S/o Ph. Ibohanbi Meitei of Khongjom Sapam Mayai Leikai and he revealed that he is an active member of KYKL having Army No. 105. As such, he was arrested at 4.30 am of the day.

A case has been registered at Andro Police Station and investigation is going on.

2. On 14/12/2018 at about 8.35 am, on receiving a reliable information about the presence of RPF/PLA cadres in and around Wangjing area, combined team of CDO Unit, Thoubal and 26 AR immediately rushed to the area and conducted search of the suspected persons(s). During the search, one unknown person who was found standing at Wangjing Bazar near bridge in a suspicious manner was detained for verification. On verification, the individual identified himself as Arambam Subashchandra Meitei @ Ningthem (40) S/o (L) A. Ibopishak of Wangjing Awang Leikai Hodamba and was found be a cadre of RPF/PLA holding the post of S/S 2nd Lieutenant. As such, he was arrested at 9.15 am of 14/12/2018.

A case has been registered at Thoubal Police Station and investigation is going on.
