

PRESS RELEASE

Imphal, the 27th November, 2018

1. On 24/11/2018 at about 11.45 pm, a team of Lilong PS including women Police personnel during search operation in the house of Md. Zuma Khan @ Tomba (28) yrs S/o (L) Md. Muhamjam of Lilong Nungei Khongbam seized 117 nos. of SP capsules and 40 nos. of N-10 tablets from the possession of Md. Zuma @ Tomba. He was arrested and seized the drugs by observing formalities. On preliminary questioning he disclosed that the drugs were brought from one Md. Safar @ Najir S/o (L) Md. Siraj Ahamaed @ Sanakhomba and his wife of Lilong Nugei for selling for his wrongful gain. On follow up action, the Police team along with Civil organization ALADA, Lilong rushed to the house of Md. Safar @ Najir of Lilong Nungei and conducted house search. During the search (i) 897 nos. of SP Capsules (ii) 1548 nos. of WY tablets (iii) 5 nos. of WINCIREX Cough Syrup bottles and (iv) one liter of extract bottle containing suspected to be codine Phosphate, marked as SILVER DEW on the bottle were recovered from the house of Md. Safar @ Najir of Lilong Nungei. As such, Md. Safar @ Najir and his wife were also arrested from their house and seized the recovered drugs by observing formalities.

A case has been registered at Lilong Police Station and investigation is going on.

2. On 25/11/2018 at about 4.00pm based on a reliable information about the movement of some valley based underground organization in and around Ngaikhong and Bishnupur area. Immediately, a combined team of Bishnupur District Commandos and team of 5/11 G.R conducted frisking and checking at Joypur Khunou. During the frisking and checking over the passenger vehicles plying from Imphal to Churachandpur, one unknown person was detained for verification due to his suspicious manner. On verification, he identified himself as Khaidem Ranjit @ Hitler (46) yrs S/o (L) Kh. Lamphel Singh of Tangjeng Khunjao Awang Leikai, an active cadre of RPF/PLA organization. On preliminary verification, he revealed that he joined the said organization in the year, 2004 through one Jibon Singh of RPF/PLA organization. He got basic military training at phailen, Churachandpur District under MC (Manipur Commission) of 273 of 2004 batch. Further, he revealed that he hold the rank of Captain and working as a Commander of GHQ Nongket, Myanmar. He was arrested at the spot by observing formalities.

A case has been registered at Bishnupur Police Station and investigation is going on.
