

**PRESS RELEASE**

Imphal, the 29<sup>th</sup> January, 2019


1. On 28/01/2019 at 10:00 a.m. a combined team of 15 AR and CDO I/E conducted mobile frisking and checking at Nongada near community hall. During the frisking and checking an active member of KCP (Moaist) namely Chabungbam Bishwamitra (23) years S/o Ch. Ibocha Singh of Seijang Makha Leikai was arrested.

A case has been registered at Lamlai Police Station and investigation is going on.

On 27/01/2019 at 4:10 p.m. relying on the materials of Sangai English daily and Sangai Manipuri Edition of 26/01/2019, a team of City Police Station arrested 2 (two) persons namely (1) Oinam Milan Singh (49) years S/o Oinam Kokngang Singh of Wangkhei Hijam Leirak, Imphal East District, Manipur from KASIL (Kangleipak Apunba Sinpang Lup) office located at Wangkhei Keithel Ashangbi and (2) Kshetrimayum Gyanendra Singh (48) years S/o Ksh. Lukhoi Singh of Lairikyengbam Leikai Salal Leirak, RO of IMC (Imphal Municipal Corporation) for taking huge amount of money in the name of making vendor littering cards from 330 vendors in the month of June, 2018. Later on, while checking by the vendors, the cards are found to be fake cards. Incriminating articles were seized from their possession.
