On 14/05/2019 at about 12:35 pm, based on reliable information, a combined team of District Police Commando, Imphal East and 6 Assam Rifle launched a counter insurgency operation at Sanjenbam Imphal East. During the operation one active member of Manipur Naga Revolutionary Front (MNRF) namely, Shanglai Sothemring (31) yrs S/o (L) Shanglai Shimreishang of Kamjong District was arrested from foothill of Sanjenbam Nungpokpi Ching along with .303 Rifle marked as FTR61M00879190 with one empty magazine was seized from his possession.

A case has been registered at Lamlai Police Station, Manipur and investigation is going on.

On further revelation by Yenkhokpam Romen Singh, another active cadre of PREPAK namely, Thangsabam Maradona @ Naocha (30) yrs S/o T.Dilak Meitei of Wangkhei Tokpam Leiaki was arrested from Kongba Kshetri Leikai near pukhri Achouba of Imphal East District.

A case has been registered at Porompat Police Station, Manipur and investigation is going on.
