1. On 22/06/2019, a team of District Police Imphal East, Heingang Police Station arrested two persons namely, (i) Shahawaz Ansari (34) yrs S/o Md. Rafiq of Rahiman Colony, Delhi Bypass Road, Brahmपुरi, Jipur, Rajasthan and (ii) Md. Ayub (32) yrs S/o Almuddin of H.N. 398 Van Vihar Colony, Kaachi Basti, Delhi Bypass Road, Jipur, Rajasthan from their respective residences who are involved in cheating innocent people by impersonating as Dr. Anman of Manipal Hospital Goa. Shahawaz Ansari executed the plan by posting comments through Youtube videos and whatsapp messages, offering money to gullible public to donate their kidneys. Both of them collected money from interested donors in the name of registration money for medical tests of the person through online transaction in the bank account of accused Md. Ayub. Afterwards, when money was received they would avoid the innocent donors by citing various reasons. Thus many innocent people across various cities and states of the country have been cheated and victimized by them. Therefore, general public is hereby informed to be aware about such fraudulent advertisements being circulated through the internet and to take precautionary measure regarding such fraudulent activities in the future.

A case has been registered at Heingang Police Station and investigation is going on.

2. On 03/07/2019 at about 03.50 pm, acting on specific information a combined team of District Police, Imphal East and 5 JAK Rilles conducted mobile frisking and checking in and around Khundrakpam. During the frisking and checking one active member of Revolutionary People's Front/People Liberation Army (RPF/PLA) namely, Nongthombam Gonson Singh (a. Justin) (25) yrs, S/o N. Landou Singh of Haraorou Mamang Leikai, Sagolmang was arrested from Khundrakpam near KC High School.

A case has been registered at Heingang Police Station and investigation is going on.
