Imphal, the 4th September, 2019

1. On 2/09/2019 at about 1.00 am acting on specific information, a combined team of District Police Lilong, Thoubal and member of Anti-Social Element Prevention Youth Committee, Lilong Chingkhams Makha arrested one drug peddler namely, Md. Anwar Khan @ Achouba (26) yrs S/o (L) Md. Samsurddin of Lilong Chingkhams Makha from his house along with (i) 836(eight hundred and thirty six) nos.of blue colour cylindrical capsules suspected to be SP capsule (ii) One blue colour small pouch containing 182 (one hundred eighty two) nos. of reddish colour tablets suspected to be WY tablets and (iii) 2 (two) nos. of cough syrup bottles marked as "Codylate" were recovered from his possession.

A case has been registered at Lilong Police Station and investigation is going on.


2. On 03/09/2019 at about 11.30 am acting on specific information, a team of District Police Commando, Bishnupur conducted frisking and checking at Kwakta Bazaar. During the frisking and checking one active worker of RPF/PLA organization namely, Md. Siraj Ali @ Boicha S/o Md. Samsin Ali of Kwakta Maronglou W/No. 8 was arrested from the spot along with 1(one) IED remote control from his possession.

A case has been registered at Moirang Police Station and investigation is going on.

3. On 03/09/2019 at about 3.30 pm, a team of District Police Commando, Thoubal were on frisking and checking duty at Kiyam Siphai Thong Ahanbi. During the frisking and checking two members of KCP(Noyon) group namely, (i) Thingujam Ingocha Singh (50) yrs S/o (L) Th. Roton Meitei of Thoubal Kiyam Mayai Leikai and (ii) Ningthoujam Ingocha Singh (50) yrs S/o (L) N.Yaima Meitei of Thoubal Kiyam Siphai Tangjeng were arrested from the spot along with incriminating articles from their possession.

A case has been registered at Thoubal Police Station and investigation is going on.
