

**Subject:** A complaint for taking necessary legal action under Section 200, 499 R/W 500, 504, 505 (b) of IPC against Smt. Th. Brinda w/o R.K. Chinglensana of Khwai Yaiskul Janmasthan, Imphal West, Manipur for her statement made in the media which has caused irreparable loss to our public perception and reputation; and also lowered majesty of the Hon'ble Manipur Legislative Assembly.

Sir,

That the present Complainants are the sitting MLAs being elected from different Assembly Constituencies within the Imphal West District for the 12<sup>th</sup> Manipur Legislative Assembly for the term 2022-2027. The brief fact and reason for filing the present complaint petition are narrated here under:

1. That we are the sitting MLAs being elected from different Assembly Constituencies within Imphal West District. We are rendering our public service to the people of our State and respective constituencies without any kind of blemish which will affect our reputations. As the people of our respective constituencies have full faith in us, we have been elected from our respective Assembly Constituencies to the 12<sup>th</sup> Manipur Legislative Assembly Election held in March 2022.
2. That it is an undisputable fact that the State Government under the leadership of Hon'ble Chief Minister of Manipur, Shri N. Biren Singh is taking a strong step to combat the rising menace of drugs in Manipur. To uproot this detrimental threat from Drug Trafficking from the soil, State Government launched campaign "*Nisha Thadokshi*" and "*War on Drugs*" in 2018. Under this campaign the Hon'ble Chief Minister aimed to destroy illegal poppy cultivation in the hilly regions of the State curtailing its distribution and trade using coercive and non-coercive methods.

In the drive against the drugs and to win the 'War on Drugs', in the 3<sup>rd</sup> Session of 12<sup>th</sup> Manipur Legislative Assembly took a unanimous resolution on

3.3.2023 by all the Members of the House irrespective of party lines to designate all its 60 (sixty) Members (MLAs) of the House to be warriors of the "War on Drugs" campaign. We are also actively involved in the War Against Drugs.

As a result of the State Government's War against Drugs, law enforcement agencies of the State have destroyed about 18,664.5 acres of poppy cultivation in the State since 2017 till February -March, 2023; and about 2,518 individuals belonging to different communities have been apprehended under ND&PS Act during the period from 2017-2023. It may not be out of place to mention that cash Award of Rs. 10 lakh was even awarded to a village in Ukhrul District for voluntary destroying of Poppy plants grown in the village. Even drones are used in destroying poppy cultivation in hilly terrain from time to time. The seriousness and the commitment of the BJP led State Government to protect the precious lives of the general public, particularly the youth of the State as well as the rest of India can be will summed up as per the comparative table as under: -

These committed actions of the BJP led State Government have inspired and encouraged all of us to work collectively against the drug menace in the State, and also against poppy plantations in all the Districts of Manipur, particularly in the Hill Districts of Manipur for the sake of our future generations and the BJP led State Government has successfully destroyed 18,664.5 acres of poppy plantation from February, 2017 to March-April, 2023 all across the Districts of Manipur. We may also recall that in the Churachandpur District alone more than 2699.8 acres of poppy plantations were destroyed by the State Government between 2017 to April, 2023. The financial loss caused by these poppy destructions in Churachandpur District is one of the main reasons as to why these Narco-Terrorists have started the riots in Churachandpur on 3<sup>rd</sup> May, 2023 against the State Government and Meitei Community.

Moreover, the State Government has also started identifying illegal immigrants/ influx from Myanmar by constituting a Cabinet Sub-Committee (CSC). And in the month of March and April, 2023, the said Cabinet Sub-Committee (CSC) has started conducting different spot enquiries for identification of illegal immigrants in various parts of the State including Churachandpur District and all these legal actions has agitated the illegal immigrants residing in Churachandpur and also the Kuki Militants Organizations. And they all started the violence in Churachandpur from 10:30 am onwards on 3<sup>rd</sup> May, 2023 in the name of Tribal Solidarity March.

4. The present violence in Manipur is directly connected with the Government policy on war against drugs and poppy plantations and also the initiative taken up for identification of the illegal immigrants. Amidst such a volatile situation of the State, on 27.6.2023, Smt. Brinda Thounaojam organized a Press Conference without any responsibility or maturity and has made various

false statements which are also available in various social media and public platforms such as YouTube, Face Book, WhatsApp etc. under the Caption,

**"Nobody dare to challenge the unity of Manipur: Th. Brinda".**

5. That in the said viral video, Smt. Th. Brinda has made many false and fabricated statements without any basis or foundations. And out of which, she has made specific statements against all the sitting Hon'ble MLAs, politicians and others without any cogent evidence to support her statement. Some of the statements are highlighted hereunder for easy appreciation –

- (starting from 7:00 minutes) that almost all the 60 members of the Manipur Legislative Assembly are involved in the Drug Cartel, and has spread from State Assembly to Burma and reached upto China. It is also stated that the Drug Cartel has the ability of buy all those who can be brought including State Government and even has 99.9% chances of the involvement of Hon'ble Parliament of India and the Hon'ble Manipur State Assembly including it's Members.
- (starting from 10:00 minutes) that MLAs and Politicians are involved in the Drug Cartel. Some are involved directly and some are involved indirectly by sponsoring and funding the Drug Cartel.
- (starting from 14:00 minutes) Manipur Drug Cartel is an international Drug Cartel and State Government and its institution are involved.

All these allegations are grossly absurd and extremely imaginative hallucination of the accused without any foundation or cogent evidence and these allegations are meant to disrepute and lower the dignity of the Hon'ble Manipur Legislative Assembly and Hon'ble Parliament of India including the Hon'ble Members of the Manipur Legislative Assembly in the eyes of general public of Manipur and also in the eyes of the rest of the Country. Each sentence

in the Press Conference of the accused dated 27.6.2023 may be treated as the part and parcel of the present Complaint.

6. That the above statements are some of the statements amongst others which have directly damaged our conscience and reputation as a responsible MLAs and also undermined the dignity and sanctity of the August House and its Hon'ble Members. It has openly lowered the majesty the Hon'ble House and at the same time it has also maligned our hard-earned public perception as MLAs in the eyes of the general public during this sensitive hour of the State of Manipur. It further amounts to provoking and promoting enmity in the Society which is against the interest of our mother land. We have indeed suffered irreparable loss of reputation and public image by such a reckless and irresponsible statement of the accused because we have no connection whatsoever or involvement with any poppy plantations or narcotic drugs and we are only committed to fight against drug menace by supporting the War on Drugs 2.0 of the present State Government led by BJP for the sake of our future generation.

The complainants came to know about such statement of the said accused in the social media i.e., Facebook on 5<sup>th</sup> July, 2023 within jurisdiction of this Police Station.

In the above fact and circumstances, it is requested for taking up necessary legal action including registration of FIR against the above-mentioned culprit to punish her in accordance with the law.
